SUBJECT: Naming the Argonaut Community and Teen Center "Evelyn Moore Community  
and Teen Center"

### SUMMARY

The Freeport Manor Neighborhood Council has requested that the Argonaut Community Center name be changed to the Evelyn Moore Community Center. A brief background of Evelyn Moore's services to the community and a recommendation is included herein.

### BACKGROUND INFORMATION

Evelyn Moore served as an active member of the Freeport Manor Neighborhood Council for over eleven years including eight years as president. She was a major force in the cooperative venture by the Freeport Manor Neighborhood Council and the City of Sacramento to develop, and subsequently program, the Argonaut Community Center to meet the needs of the surrounding community. In particular, Mrs. Moore was instrumental in acquiring such capital improvements as street lights for the center and surrounding park site and in providing food programs for the neighborhood children. Evelyn Moore worked closely with local schools, the City and the residents in her many efforts to improve the quality of life in her community. These efforts were in addition to her many responsibilities as a mother of seven children, re-entry student and subsequent Sacramento Unified School District employee. Evelyn Moore remained an active and involved citizen up until her death in December 1983.


RECOMMENDATION


To Whom It May Concern:
