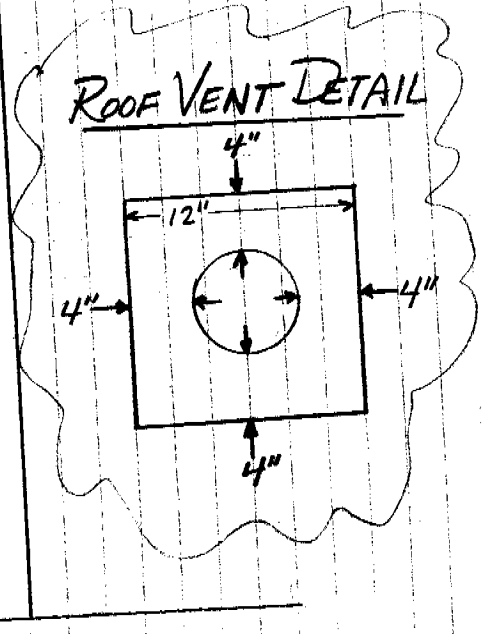

BOTTOM OF FIREPLACE IS 9" FROM BOTTOM OF BRICK PAD



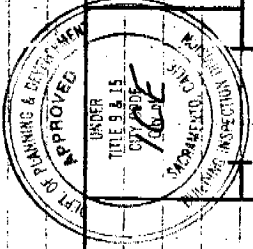
10" FROM WALL TO BACK OF FIREPLACE
