## SUMMARY

BE IT RESOLVED BY THE REDEVELOPMENT AGENCY OF THE CITY  
OF SACRAMENTO:

Section 1. The Preliminary Budget dated December 21, 1981 is hereby approved. Said budget shall constitute the budget of the Redevelopment Agency of the City of Sacramento for the 1982 calendar year.

Section 2. New budget positions or classifications are hereby approved subject to classification review by the Interim Executive Director.

Section 3. Unspent appropriations relating to capital improvements projects in progress at December 31, 1981, are carried forward in the calendar year 1982 budget.

Section 4. As to the items contained in Section G, the Capital Improvements Program, and those items only, the budgeted amount for any item therein may be amended by majority vote of the Governing Body of the entity or entities actually undertaking the improvement. Such an amendment so enacted shall be deemed to have been effected by all of the entities originally establishing the budget without further action by those entities not directly involved in the expenditure of the funds in question.
