

RESOLUTION OF INTENTION No. 2136

WHEREAS, in the opinion of the City Council of the City of Sacramento, the public interest and convenience require that the work and improvement hereinafter described should be done.

NOW, THEREFORE, the said City Council of the City of Sacramento does hereby resolve and declare that it is the intention of said City Council to order the following work and improvement to be done in said City.

To close, vacate and abandon that certain street or road which begins at the south line of Y Street, at a point between 3rd and 4th Street and running southerly from Y Street, being more particularly described as follows:

Beginning at a point on the southerly line of Y Street, of the City of Sacramento, at its intersection with the westerly line of a 40' Road; said point being further described as being located S. 71° 01.50' E. 1024.44 feet, thence S. 18° 58.50' W. 40 feet from a stone monument marking the center line intersection of Front Street and Y Street, of the City of Sacramento; thence from the point of beginning S. 18° 58.50' W. 1025 feet along the westerly line of said road to the southerly line of the lands owned by "Sacramento Industrial Corporation," thence S. 49° 34.30' E. 4298 feet along the southerly line of the lands of "Sacramento Industrial Corporation;" thence N. 18° 58.50' E. 1040.72 feet along the easterly line of said road to the southerly line of Y Street; thence N. 71° 01.50' W. 40 feet to the point of beginning.

And said City Council does hereby determine and declare that the exterior boundaries of the district of lands which will be affected or benefitted by said work and improvement are described as follows:

Beginning at a division fence corner on the southerly line of Y Street, of the City of Sacramento, and which point of beginning is further described as being located N. 71° 01.50' W. 78.21 feet from the intersection of the center line of Front Street, produced southerly, with the southerly line of "Y" Street; thence from the point of beginning S. 19° 10.84' W. 611.95 feet along the division fence line making the easterly line of the lands now or formerly owned by Union Oil Company to a division fence line; thence S. 49° 34.30' E. 3408.57 feet along a division fence line making the northerly line of the lands now or formerly owned by Alice and Fredrick A. Miller, Nora V. Lewis and Flood V. and Wm. R. Flint, respectively to a division fence corner; thence N. 19° 42.50' E. 819.29 feet along a division fence line marking the westerly line of the Odd Fellows Cemetery, Masonic Cemetery and the City Cemetery respectively to a division fence corner; thence N. 70° 53.75' W. 621.22 feet along a division fence line marking the southerly line of the lands now or formerly owned by National Bank of D. O. Mills, to a division fence corner; thence N. 8° 10.16' W. 430.15 feet along a division fence line marking the westerly line of the lands of National Bank of D. O. Mills to a point; thence N. 11° 42.25' W. 761.70 feet along said division fence line on westerly line of the lands of National Bank of D. O. Mills to the southerly line of said "Y" Street; thence N. 71° 01.50' W. 1974.58 feet along the southerly line of "Y" Street to the point of beginning and containing 68.746 acres, more or less.


The entire damages, cost and expenses of said work and improvement shall be and are hereby made chargeable against and shall be assessed upon the land in the district described as aforesaid. All of the said work and improvement shall be done in accordance with

the provisions of the Act of the Legislature of the State of California entitled "An Act to provide for laying out, opening, extending, widening, straightening or closing up in whole or in part any street, square, lane, alley, court or place within municipalities and to condemn and acquire any and all land and property necessary or convenient for that purpose" approved March 6, 1889, and the several Acts amendatory thereof or supplemental thereto.

The Street Superintendent is hereby directed to cause notices of the passage of this resolution to be printed and posted in accordance with law, and to cause a notice similar in substance to be published in the Sacramento Union, a daily newspaper published and circulated in said City of Sacramento.


