- A. OAK PARK REDEVELOPMENT ADVISORY COMMITTEE to fill three (3) positions. This opening represents one (1) term expiration and two (2) seats where appointees resigned prior to their term expirations in January 2007. Appointees are nominated by Council District 5, appointed by the Mayor and confirmed by the City Council.

OPEN APPLICATION PERIOD 03-29-06; APPLICATIONS DUE 04-28-06.

- B. SACRAMENTO ARMY DEPOT REDEVELOPMENT ADVISORY COMMITTEE to fill six (6) positions. This opening represents all six seats with term expirations in April 2006. Appointees are nominated by Council District 6, appointed by the Mayor and confirmed by the City Council.

OPEN APPLICATION PERIOD 03-29-06; APPLICATIONS DUE 04-28-06.

- C. SACRAMENTO CITY/COUNTY BICYCLE ADVISORY COMMITTEE to fill three (3) positions. This opening represents two (2) seats with term expirations in May and one seat which had expired in 2005. Residency in the city is required. Members are appointed by the Mayor and confirmed by the City Council.

OPEN APPLICATION PERIOD 03-29-06; APPLICATIONS DUE 04-28-06.

- D. NORTH SACRAMENTO REDEVELOPMENT ADVISORY COMMITTEE to fill nine (9) positions. This opening represents seven (7) seats with term expirations in April, and two (2) seats where appointees resigned prior to their term expirations in 2007. Appointees are nominated by Council Districts 2 and 3, appointed by the Mayor and confirmed by the City Council.

OPEN APPLICATION PERIOD 03-29-06; APPLICATIONS DUE 04-28-06.

- E. SACRAMENTO HERITAGE, INC. BOARD OF DIRECTORS to fill two (2) positions. This opening represents both seats with term expirations in 2005. City residency is not required. Members are appointed by the Mayor and confirmed by the City Council.
