SUBJECT: REPORT BACK - SOURCES OF FUNDING FOR BIKEWAYS

SUMMARY

This report provides information regarding Bikeways C.I.P. as requested by the Budget & Finance and Transportation & Community Development Committee (Joint Committee) on May 1, 1990. This report is for committee information only.

BACKGROUND

This report provides information regarding Bikeways C.I.P. as requested by the Joint Committee on May 1, 1990.

The various funding sources for the 1990-91 Bikeway Program are as follows:

1.	Transportation Development Act Funds	\$200,000
2.	Measure A	\$ 80,000
3.	Quimby	\$ 75,000
4.	Capital Grants	\$150,000
	Total	\$505,000

The South Natomas Facilities Benefit Assessment District has identified \$108,000 for bikeway projects in the fiscal year 1992-93.

The Bannon Slough Bike Trail in South Natomas was funded from previous years funding in the amount of about \$800,000. Construction of the Bannon Slough Bike Trail is scheduled to begin in November of this year.

In addition to the bikeway facilities identified in the C.I.P., construction of new streets identified to have bike lanes will be constructed to include the bike lanes at no cost to the bikeway program. Bikeway facilities adjacent to or on parcels with proposed developments can be constructed as a condition of the development.

The Sacramento Bikeway Master Plan Update currently underway will be forthcoming with suggested bikeway construction program in phases of 5 year increments.




