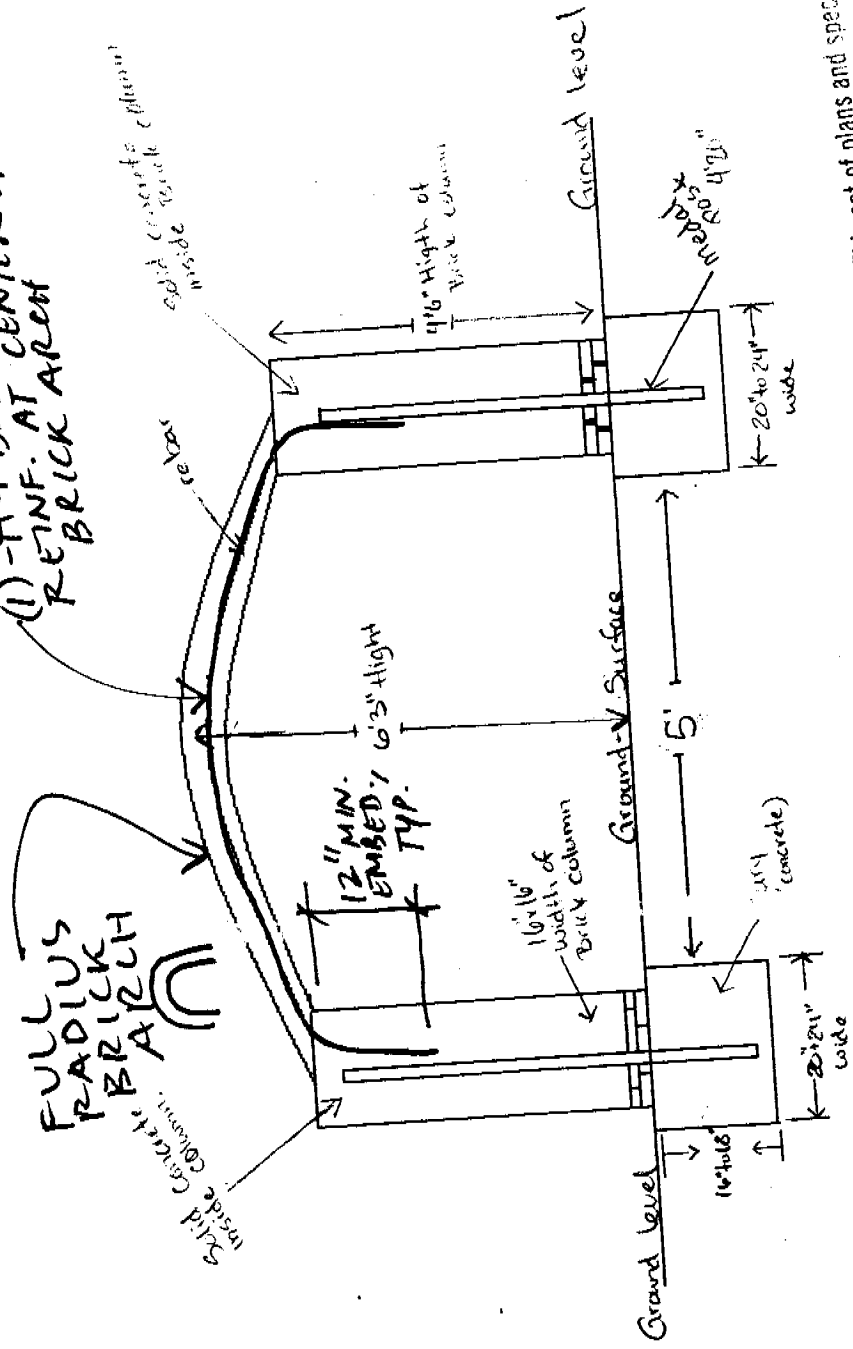

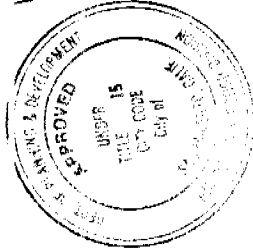
FULL RADIUS BRICK ARCH
