REPORT SECOND QUARTER 1990**

Attached for your review is a copy of the June 1990 Employment Statistics Report covering your Department. Also attached are charts which show changes which have occurred in the total full time career workforce since December 1989. I am also including a copy of the summary of new hires, promotions and terminations through the first half of 1990.

As you can see, there continues to be a slight increase in the percentage of minorities in the City workforce for the first half of 1990. The minority workforce increased from 31.89% to 31.91% during this period. We have also had a slight increase in the percentage of females in the workforce during this period.

Overall, the percentage of minorities increased in six of the nine occupational categories during this reporting period. The percentages of females also increased in six of the nine occupational categories during this period.

Please continue to route copies of this report and accompanying charts to those supervisors and managers who assist you in making hiring decisions. Each appointing authority should refer to the employment statistics report and previously circulated Affirmative Action Targets 1989-90 Fiscal Year Chart.
