

STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and can approve it with the following conditions of approval:

1. Scope of work is limited to the items listed in these conditions
2. ~~Provide all new stucco to exterior~~
3. Retain wood trim at windows and doors
4. Provide new windows throughout. Windows to be aluminum sliders.
5. Windows on front elevation must be gridded. Gridded windows are optional on all other elevations.
6. All other notes and drawings on the final plans as submitted by the applicant are deemed conditions of approval. Any changes to the final set of plans stamped by Design Review staff shall be subject to review and approval prior to any changes.
