

RESOLUTION OF INTENTION # 2527

WHEREAS, it is the opinion of the City Council of the City of Sacramento that the public interest and convenience require that the work hereinafter described should be done;

NOW THEREFORE, the said City Council does hereby resolve and declare that it is the intention of said City Council to order the following Street Work to be done, to-wit:

To close, vacate and abandon that portion of 8th Street, in the City of Sacramento, which lies north of the northerly line of D Street and south of a line drawn from a point on the westerly line of 8th Street, 67.9 feet northerly from the northwest corner of 8th and D Streets to a point on the easterly line of 8th Street, 113.26 feet northerly from the northeast corner of 8th and D Street; reserving, however, the right of entry to repair, maintain, and construct sewer, water and gas pipe and aerial or underground power, telephone and other communication facilities now in place in said 8th Street or which from time to time may be placed therein. All proceedings in connection with the aforesaid closing are to be taken subject to such reservations and exceptions.

And said City Council does hereby determine and declare that said proposed work and improvement is of more than local or ordinary public benefit and will affect and benefit the lands and district hereinafter described, and which said district is hereby declared to be the district affected, and benefited by said work and improvement, and that, therefore, the entire damages, costs and expenses of said work and improvement shall be, and are, hereby made chargeable against, and shall be assessable upon said lands and district, which district is within the City of Sacramento, County of Sacramento, State of California.


The exterior boundaries of the lands affected and benefited by said work and improvement are particularly described as follows, to-wit:

On the north by a line drawn from a point on the easterly line of 8th Street, 113.26 feet northerly from the northeast corner of 8th and D Street to a point on the center line of 9th Street, 317.14 feet northerly from the intersection of the center line of 9th Street and the northerly line of D Street, on the east by the westerly line of 9th Street, on the south by the northerly line of D Street and on the west by the easterly line of 8th Street.


And the Said City Council does hereby elect to proceed to do said work under the provisions of Division 9, Part 3, "Street and Highways Code", the "Street Vacation Act of 1941", being an Act of Legislature of the State of California, approved May 13th, 1941.

Notice is hereby given that all persons interested in or objecting to the proposed vacation, may appear before the said City Council, in the Council Chamber, located on I Street between 9th and 10th Streets in said City on August 10, 1945, at 8:00 P.M., and be heard in the matter.

The Sacramento Union is hereby designated as the daily newspaper published and circulated in said City, in which this Resolution shall be published; and the Superintendent of Streets is hereby directed to post notices of the passage of this Resolution in the manner as required by law.
