Mr. Deise moved that Eligible Register No. 207 be abolished as of March 10, 1949, the effective date of the new Patrolman Eligible Register #223; seconded by Mr. Marty and motion carried.

OUTSIDE EMPLOYMENT

In response to an inquiry from the Board, the City Attorney submitted a written opinion, stating that in accordance with Sections 105 and 159 of the City Charter, the members of the Police and Fire Departments shall not follow any other profession, calling or business, but shall devote their entire time to the performance of their official duties and that the Civil Service Board does not have the power or authority to approve applications for special work permits for members of those departments; that the Civil Service Board could at the suggestion of the City Manager adopt rules and regulations for the granting of special work permits for miscellaneous employees which would not be inconsistent with the performance of their duties with the City.

City Manager Cavanaugh personally appeared before the Board with reference to the foregoing opinion from the City Attorney and requested that the members of the Board consider the adoption of rules and regulations restricting City employees from accepting employment, positions or services outside of City service except upon written application to be filed with and acted upon by the Board. The City Manager stated that the Chiefs of the Fire and Police Departments had been instructed by him to strictly enforce the provisions of the City Charter, prohibiting employees in those departments from working in outside employment.

After general discussion by members of the Board and the City Manager, the foregoing matter was taken under advisement for further consideration at the next regular meeting of the Board.
