(D-1) APN: 225-0310-020, 225-0140-037, 38, 39; Entitlements to develop 835,200 gross square feet of office, retail and commercial development on 65.1 gross acres within the Gateway West and Cambay West PUD in the EC-50 PUD zone; A. PUD Schematic Plan Amendment to allocate 835,200 square feet of office and support retail uses on the Gateway West Schematic Plan.
