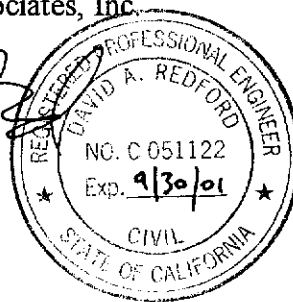
Epoxy  
dowel: Verified correct installation of epoxied allthreads into existing pilasters for mounting brackets per manufacturer's instructions and project plans.

Verified correct installation and tension of high strength A325 bolts for structural steel framing connections. Monitored contractor compliance with Welding Procedure Specifications (WPS). Checked welder certification records.
