

MINUTES OF THE REGULAR MEETING

MINUTES OF THE REGULAR MEETING OF FEBRUARY 16, 1982

President Russell appointed Board Member Mabbutt as President Pro Tem., in order to be able to act on the approval of the minutes.

Reference was made to correspondence from Ms. Thornhill, and the Board noted that as a result of the previous Board action approving Ms. Thornhill's request for transfer, the appeal was withdrawn.

RECOMMENDED DECISION OF ADMINISTRATIVE LAW JUDGE

Appeal of Sophie Joseph

Ms. Sophie Joseph, Stenographer Clerk III, and Mr. Dan Bonebrake, Senior Employee Relations Representative, addressed the Board, and Ms. Joseph requested that final decision on her appeal be postponed until a full Board was convened.

There was some discussion on this issue, and motion was made to deny the request for a continuance of this appeal.

March 2, 1982

Ms. Joseph distributed a letter to the Board in which she challenged the proposed decision of the Administrative Law Judge. Ms. Joseph informed the Board of her areas of concern, including the fact that one of the City's witnesses did not return to the hearing in the afternoon, and discussed an altered doctor's certificate which had been introduced as evidence. Ms. Joseph also cited harrassment on the job, and the fact that she was not allowed to use her vacation time in lieu of leave-without-pay.

Mr. Bonebrake addressed the Board and stated that the appellant had walked off the job, that it was the policy of the City Clerk's Office not to allow vacation time to be used in lieu of leave-without-pay, and that during the hearing she informed the Administrative Law Judge she would not go back to the City Clerk's Office.

There was some lengthy discussion on the background of the disciplinary actions and it was noted that Ms. Joseph had refused to follow a directive that she see a City physician, which resulted in one of the disciplinary actions.

The Board went into executive session at 2:55 p.m.

The Board reconvened at 3:11 p.m.

Motion was made to uphold the recommendations of the Administrative Law Judge and deny the appeal of Sophie Joseph.

Ms. Joseph then asked whether she was entitled to longevity pay. Mrs. Giles told her that this would be looked into, and that Mrs. Giles would advise her.

CLASSIFICATION STUDY - First Reading

- b. Assistant/Associate Planner

Mrs. Verna Banks, Senior Personnel Analyst, addressed the Board and referred to the supporting correspondence which outlined the recommended revisions to the class specifications for Assistant/Associate Planner and the establishment of a new classification of Junior Planner.

March 2, 1982

Mrs. Banks distributed revised copies of proposed class specifications to the Board which added a phrase under the "License or Certificate" section, as follows: "Possess and maintain an appropriate, valid California motor vehicle operator's license. Individuals who do not meet this requirement because of a disability may be reviewed for accommodation on a case-be-case basis.

This was amended by staff, and it was requested that the words "physical handicap" be used instead of "disability".

After some discussion, motion was made to approve the class specifications for Junior Planner and Assistant/Associate Planner for first reading as amended, and pass for second reading.

PROPOSED CIVIL SERVICE BOARD RULE 7.4 CHANGE - First Reading

Mrs. Banks referred to the proposed rule change which would add the classification of Junior Planner to the list of other classifications requiring probationary periods in excess of six months.

Motion was made to approve proposed change to Civil Service Board Rule 7.4 for first reading, and pass to second reading.

Historian - Architecture and Preservation

Ms. Banks reminded the Board that this matter had been brought to the Board at a previous meeting, and that it had been requested that staff review the section on "Experience and Education". Mrs. Banks informed the Board that this section had been revised, and the education requirements expanded to include a Bachelor's Degree or the equivalent.

Motion was made to approve for first and second reading, and adopt the revised class specification for Historian - Architecture and Preservation.



ELIGIBLE LIST ESTABLISHED


#1824-D - Equipment Mechanic II
