MINUTES:

Jim Bloodgood, Supervising Engineer, gave an overview of project recommendations to the Sacramento Area Council of Governments (SAGOG) for the Regional Transportation Improvement Program. Mr. Bloodgood stated that the following modifications needed to be made to the recommended project list: (1) Freeway widening of Interstate 80 from I-5 to Watt Avenue (2) Deleting #5 (Elvas/Richards Connector) in the non-interstate project list.

Committee member Terry Kastanis asked that Mr. Bloodgood look into the status of soundwall installations on Mack Road between 47th Avenue. He also asked that Item #3 (Signalization of southbound to westbound ramp at Mack Road and landscape freeway around interchange) be moved as Item #2 on the non-interstate priority list.

It was moved by Committee member Shore and second by Committee member Bradley to adopt staff recommendation.


