March 5, 1931.

The Civil Service Board of the City of Sacramento met in regular session on the above date at 8:00 o'clock P. M. in the office of the Board, Room 106 City Hall, President Chenu presiding.

PRESENT: Commissioners Maloney and Chenu.  
ABSENT: Commissioner Weisman.

The reading of the minutes of the previous meeting was dispensed with.

Mrs. Mary B. White, an employee of the City in the Health Department, appeared before the Board with reference to her employment record with the City of Sacramento. The Board questioned Mrs. White, and reviewed the reports submitted. Commissioner Maloney moved that this matter be laid over in order to permit of further consideration. The motion was seconded by Commissioner Chenu. The vote was as follows:

AYES: Commissioners Maloney and Chenu.  
NOES: None. ABSENT: Commissioner Weisman.

Mr. Joseph Bacchi, a candidate in the recent examination for Uniform Fireman, appeared before the Board upon request with reference to his naturalization papers. The Board found the papers presented by Mr. Bacchi to be in order and satisfying the requirements of applicants for examination.

Mr. Hope C. King, a candidate in the recent examination for Uniform Fireman and claiming preference in the examination under Section 45 of the City Charter, appeared before the Board upon request with reference to his military discharge. Commissioner Maloney moved that this case be laid over. The motion was seconded by Commissioner Chenu. The vote was as follows:

NOES: None.

ABSENT: Commissioner Weisman.

Robert McColloch, a candidate in the recent examination for Uniform Fireman and claiming preference in this examination under Section 45 of the City Charter, appeared before the Board upon request regarding his military discharge. Mr. McColloch was questioned as to the probable date when he would obtain discharge papers in lieu of those lost. Commissioner Maloney moved that this case be laid over. The motion was seconded by Commissioner Chenu. The vote was as follows:

ABSENT: Commissioner Weisman.

Arthur McMillan, a candidate in the recent examination for Uniform Fireman and claiming preference in the examination under Section 45 of the City Charter, appeared before the Board upon request with reference to his military discharge. Mr. McMillan's discharge papers were found to satisfy the requirements demanded of applicants claiming preference on examinations under Section 45 of the City Charter.

Carl C. Whiteaker, a candidate in the recent examination for Uniform Fireman and claiming preference in this examination under Section 45 of the City Charter, appeared before the Board upon request with reference to his military discharge papers. Mr. Whiteaker's discharge papers were found to satisfy the requirements demanded of applicants claiming preference on examinations under Section 45 of the City Charter.

Elwood Judge appeared before the Board and requested a review of his examination papers in the recent test for Uniform Fireman. Commissioner Maloney moved that the request of Mr. Judge for a review of his examination papers be granted. The

motion was seconded by Commissioner Chenu. The vote was as follows:

The Board proceeded to review the papers of Elwood Judge and found a variance of plus four <sup>Tenths</sup> percent. Commissioner Maloney moved that the grade given Mr. Judge be corrected. The motion was seconded by Commissioner Chenu and the vote was as follows:

Lowell Moffitt, a candidate in the recent examination for Uniform Fireman, appeared before the Board and requested information with reference to his standing in this test. The Board advised Mr. Moffitt that he had failed to obtain a passing grade in one of the subjects of the examination. Upon further consideration, the Board advised Mr. Moffitt that his case would be taken under advisement.

The status of James H. Gerard, formerly an employee of the City in the capacity of Janitor, was next considered. Commissioner Maloney moved that Mr. George Sim, Superintendent of the Recreation Department, be requested to appear before the Board at their next meeting in connection with this case. The motion was seconded by Commissioner Chenu. The vote was as follows:

 NOES: None. ABSENT: Commissioner Weisman.

The case of A. J. Angelo, an employee in the Engineering Department, was brought before the Board. Commissioner Maloney moved that this case be laid over. The motion was seconded by Commissioner Chenu. The vote was as follows:

 NOES: None. ABSENT: Commissioner Weisman.

The duties of George Mento, an employee in the Health Department, were discussed by the Board. A tabulation of the duties of Mr. Mento was submitted by Dr. True, Health Officer. Mr. Mento is at present classified as a Senior Clerk. Commissioner Maloney moved that this matter be laid over. The motion was seconded by Commissioner Chenu. The vote was as follows:

AYES: Commissioners Maloney and Chenu.  
 NOES: None. ABSENT: Commissioner Weisman.

A Civil Service report dated February 15, 1931, was received showing the appointment of George F. Snyder as Laboratory Assistant as of February 15, 1931. Commissioner Maloney moved that the pay roll bearing the name of George F. Snyder be approved. The motion was seconded by Commissioner Chenu. The vote was as follows:

AYES: Commissioners Maloney and Chenu.  
 NOES: None. ABSENT: Commissioner Weisman.

The Board next gave consideration to the position of Laboratory Assistant in the Health Department. After discussing the duties of this position, Commissioner Maloney moved that action be deferred and the matter laid over. The motion was seconded by Commissioner Chenu. The vote was as follows:

AYES: Commissioners Maloney and Chenu.  
 NOES: None. ABSENT: Commissioner Weisman.

Adjournment was taken at 10:30 o'clock P. M. to meet again at the call of the Chair.
