The following reasons for this petetion are:

1. Fast speeding traffic on 47th Avenue, Between Franklin Blvd., and 24th Street.
2. Fast speeding traffic on Woodbine Avenue and Ventura Avenue.
3. Numerous amount of vehicle accidents at the corner of 47th Ave., and Woodbine Avenue.
4. Vehicles traveling West on 47th Avenue, turn left onto Woodbine Ave and due to fast speed loose control of vehicle and destroy private property.
5. Since new traffic lights was installed on Fruitridge Road and also on 24th Street, this has caused heavier traffic on 47th Ave and down Woodbine.
6. Need better traffic control in this area for speeding violations, unlicensed vehicles and unsafe vehicles taht are being used daily.
