Having been continued from the regular meeting of December 28, 1976, Joseph E. Commes, Jr., President of the Sacramento Metropolitan Chamber of Commerce spoke to the written report and recommendations relative to Economic Development.

Following Council discussion, the matter was referred to the City Manager for a report due January 25, 1977, and the matter was scheduled for the regular meeting of February 8, 1977, for Council discussion.

Robbieberr Berger, Executive Director of the County Taxpayers League, offered assistance to the Council and spoke to the Chamber of Commerce report and suggested formation of City-County Coordinating Council and "sunset" laws for programs and to set revenue limits as well as expenditure limits for the City.

Councilperson Connelly asked questions regarding the League's stand on containerization and was told League Board of Directors has endorsed principle of containerization.

Frederic A. Kahn was now present and the City Clerk administered the Oath of Office and the Oath was then ordered filed.

Councilperson Sands out at this time.

Having been continued from the regular meeting of November 30, 1976, the appeal of Mr. and Mrs. Ross Young from the Preservation Board decision to suspend issuance of a demolition permit for the structure at 1621-16th Street for a period of 180 days was heard at this time.

Dick Hastings, Preservation Director, gave a verbal report regarding negotiations with Wayne Harbarger, attorney for the appellants. Following discussion, Mr. Harbarger stated that he accepted the new stiplulations on behalf of his clients.

Councilperson Rudin moved that the hearing be closed and that it is the intent of Council to grant the appeal in part as stipulated, as follows, based on a Findings of Fact due January 11, 1977: 1. The building on the property shall be made avialable at no cost to any private party or to the City. 2. If before March 7, 1977, a written commitment is made by either a private party or the City to move the building, and the relocation process is commencing in good faith, then no demolition permit will be requested by Mr. Young for a reasonable time not to exceed sixty (60) days beyond March 7, 1977. 3. If, at the end of the demolition suspension on March 7, 1977, a private party has not made a firm written commitment to move the building, and the Preservation Board has not recommended an expenditure of funds from its revolving fund to move the building to another site, either presently owned or to be acquired by the City, that the demolition suspension will cease on March 7, 1977, and a demolition permit may be issued to Mr. Young. Councilperson Rudin had summary comments and then called on Personnel Director William Danielson to discuss the report. After a lengthy discussion concerning benefits for C.E.T.A. and part-time employees, Mayor Isenberg requested that the City Attorney prepare an opinion and/or a resolution specifically stating that Council rejects the idea of non-career employees automatically getting the full benefits of career employees without negotiation.

After further discussion, Councilperson Connelly moved to approve the report recommendations, as follows, with the condition stated by Mayor Isenberg regarding benefits and requested that the City Manager report back on the actual cost and source of funds: 1. The amendments to the Employer-Employee Relations Policy providing representation for specified seasonal, part-time and limited-term employees and for employees in special man-power programs be adopted. 2. That specified non-career employees be extended pro-rata retirement benefits. This will require an ordinance providing Section 399 benefits for certain employees working half-time and who are not eligible for PERS benefits to be enacted by July 2, 1977. Seconded by Councilperson Ferrales.

The Council, after lengthy discussion, continued the matter to January 11, 1977, for a report from the City Manager. Motion was withdrawn. Councilperson Ferrales requested that the City Attorney prepare an opinion regarding whether state law does grant non-career employees legal right to representation.
