This item is presented at this time for City Council approval of its publication for legal advertisement purposes.


BACKGROUND

FOURTH SERIES

AN ORDINANCE AMENDING SECTIONS 19.312 AND 19.313 OF THE
SACRAMENTO CITY CODE, RELATING TO REFUSE COLLECTORS' FEES
(M-518)

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

Section 19.312 of the Sacramento City Code is hereby amended to read as follows:

Sec. 19.312 Commercial refuse collector's registration fee.

Each and every person who has a commercial refuse collector's permit shall pay an annual registration fee in the sum established by resolution of the city council for each vehicle number issued pursuant to the provisions of section 19.314 of this code. This fee shall be due on the first day of the fiscal year, or on the date the vehicle number is issued, whichever is later. Fees collected pursuant to this section are in addition to taxes provided for in any other provisions of this code.

SECTION 2.

Section 19.313 of the Sacramento City Code is hereby amended to read as follows:

Sec. 19.313 Residential refuse collector's registration fee.

Each and every person who has a residential refuse collector's permit shall pay a registration fee in the sum established by resolution of the city council for each vehicle sticker issued pursuant to the provisions of section 19.315 of this code. This fee shall be paid upon application for a vehicle sticker. The fees collected pursuant to this section are in addition to taxes provided for in any other provision of this code.
