**SUBJECT: Acquisition of Lot A River Oaks East #1 (CIP #HA21)**

**SUMMARY**

This report recommends that the FY 1987-88 City budget be amended to transfer funds for the acquisition of Lot A River Oaks East #1. No additional funds are requested.

**BACKGROUND INFORMATION**

On November 14, 1986 the City Council authorized the execution of Public Improvement Proceeding No. 86121 and 86120 for the subdivision of River Oaks East #1. The terms of this agreement require that 2.828 acres be dedicated to the City for park purposes. The land is valued at \$60,107.67.

Terms of the agreement include that the amount owed to the subdivider for Lot A of River Oaks East #1, \$60,107.67, plus the credit to the subdivider from River Oaks East #1, \$77,994.43, be reduced by the amount of Quimby fees owed to the City, \$87,804.14, whereby the City shall pay the difference, \$50,297.96 (\$60,107.67 and \$77,994.43 - \$87,804.14). Funds are available in the Quimby Act Reserve to transfer to the Sacramento River Project in order that the City may pay the difference of \$50,297.96 to the subdivider.

**FINANCIAL DATA**

Funds for acquisition of Lot A River Oaks East #1, in the amount of \$50,297.96, are available from the Quimby Act Reserve Fund. No additional funds are required.

RECOMMENDATION

It is recommended that the Budget and Finance Committee approve this report and refer it to the full City Council for action. Further, it is recommended that the City Council, by resolution:

1. Authorize the purchase of Lot A River Oaks East #1 according to the terms of Subdivision Improvement Proceeding No. 86121.
2. Authorize the fund transfer of \$50,297.96 from the FY 1987-88 Quimby Act Reserve Fund to the Sacramento River project for the purchase of Lot A River Oaks East #1.
3. Authorize payment of \$50,297.96 from the Sacramento River project to Lamray Development and Construction under the terms of Subdivision Improvement Proceeding No. 86121 and 86120.
