RESOLUTION No. 921

Adopted by The Sacramento City Council on date of December 2, 1954

RESOLUTION DECLARING PROPOSITION NUMBERED C (INCREASED PENSIONS TO RETIRED PERSONS) FOR THE AMENDMENT OF THE CHARTER OF THE CITY OF SACRAMENTO SUBMITTED TO THE ELECTORS WITHIN THIS CITY AT A SPECIAL MUNICIPAL ELECTION CONSOLIDATED WITH THE GENERAL ELECTION FOR NOVEMBER 2, 1954, CARRIED AS THE RESULT OF THE VOTE CAST AND DIRECTING THE CLERK TO PREPARE A CERTIFICATE THEREOF TO BE SUBMITTED TO THE LEGISLATURE AT ITS NEXT REGULAR SESSION, AND PROPOSITION D (TERMS OF COUNCIL) HAVING FAILED TO RECEIVE A MAJORITY OF VOTES CAST BE DECLARED LOST.

WHEREAS, the Council of the City of Sacramento did heretofore resolve on August 31, 1954, to submit certain propositions Numbered C and D for the amendment of the Charter to the qualified electors of the City at a Special Municipal Election consolidated with the General Election to be held on Tuesday, November 2, 1954: and

WHEREAS, pursuant to said resolution, proceedings were regularly had and taken by the Council for the consolidation of said Special Municipal Election with the General Election pursuant to the provisions of the Elections Code of the State of California, and the Board of Supervisors were also authorized and directed, pursuant to law, to canvass the vote thereon and report the result thereof to the City Council; and

WHEREAS, the Honorable Board of Supervisors did in regular session on September 1, 1954, pass Resolution No. 13,520, authorizing the consolidation of said Special Municipal Election with the General Election and directing that said propositions be placed upon the General Election Ballot; and

WHEREAS, said Special Municipal Election consolidated with the General Election was duly and regularly held and conducted on November 2, 1954; and

WHEREAS, the Board of Supervisors of the County of Sacramento, pursuant to law and the authority vested in them, did canvass the vote upon said propositions Numbered C (INCREASED PENSIONS TO RETIRED PERSONS) and D (TERMS OF COUNCIL) on the ballot and have submitted a certificate of the results of such canvass and the same has been filed in the office of the City Clerk,

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That the Council does hereby declare that said Special Municipal Election consolidated with the General Election was duly and regularly held on November 2, 1954, pursuant to law and notice given thereof, and that the Board of Supervisors of the County of Sacramento did duly and regularly canvass the vote on said Propositions C and D and report the result of said canvass to the city, which is as follows:

PROPOSITION C

INCREASED PENSIONS TO RETIRED PERSONS

To amend Article XX of the City Charter by adding a new section providing for a maximum increase of \$25.00 per month to retired persons receiving less than \$150.00 per month and who retired prior to 1948, with smaller amounts of increase to persons retiring up to July 1, 1952, based upon 20 years of service, with proportionate increases to widows or dependents of retired persons.

PROPOSITION D

TERMS OF COUNCIL

To amend Article IV, Section 19, and Article XXI, Section 184 of the Charter of the City of Sacramento to provide for a 4 year term of office for Councilmen. Election to be held every 2 years with 5 to be elected one election and 4 to be elected at the next succeeding election.

That Proposition C for the amendment of the City Charter relative to Increased Pensions to Retired Persons, as above set forth, having received a majority of all votes cast for said proposition is hereby declared to have been duly ratified, confirmed and adopted by the People of the City of Sacramento at said election.

That the City Clerk of the City of Sacramento be, and he is hereby, authorized and directed to prepare a Certificate of the amendment, showing the approval by the qualified electors of this city of Proposition C and containing the full text of said amendment to the City Charter, as set forth in Resolution No. 825, adopted by the City Council on August 31, 1954. That he is further authorized and directed to cause said certificate of amendment to be submitted to the legislature of the State of California at its next regular session, for ratification and approval by it.

That Proposition D (TERMS OF COUNCEL) having failed to receive a majority of the votes cast is hereby declared lost.
