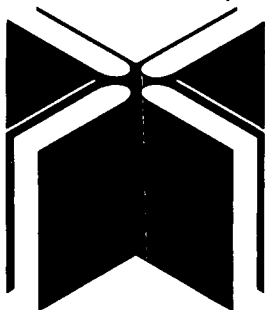

SUBJECT: RESOLUTION APPROVING EXECUTION OF EMPLOYMENT
CONTRACTS FOR MOUNTAIN-VALLEY LIBRARY SYSTEM
EMPLOYEES

SUMMARY

The Library Director requests approval by the City Council of the execution of employment agreements between City of Sacramento, acting on behalf of the Mountain-Valley Library System, and Mary E. Bass, James H. Allensworth, Anna M. Murch, R. D. Hendricks, Raleigh W. Elliott and Sheri L. Patterson. The agreements reflect cost-of-living pay increases. City Council action is required to make these agreements binding. The terms and conditions of employment covered by these agreements are to take effect on the first day of the new pay period following December 1, 1988, and were approved by the Mountain-Valley Library System Administrative Council at its meeting on February 9, 1989, in Woodland.

BACKGROUND

The Mountain-Valley Library System is a consortium of independent city, county, college, university and special libraries who have joined to form a cooperative network, providing interlibrary loans for a nine-county area in the state of California.

FINANCIAL DATA

The City of Sacramento, as fiscal agent for the Mountain-Valley Library System, Administers funds received pursuant to standard agreements between the State Department of Education, the State Library and the City of Sacramento. There is no obligation on the part of the City of Sacramento to continue personnel employed with project funds after these funds have been expended.




