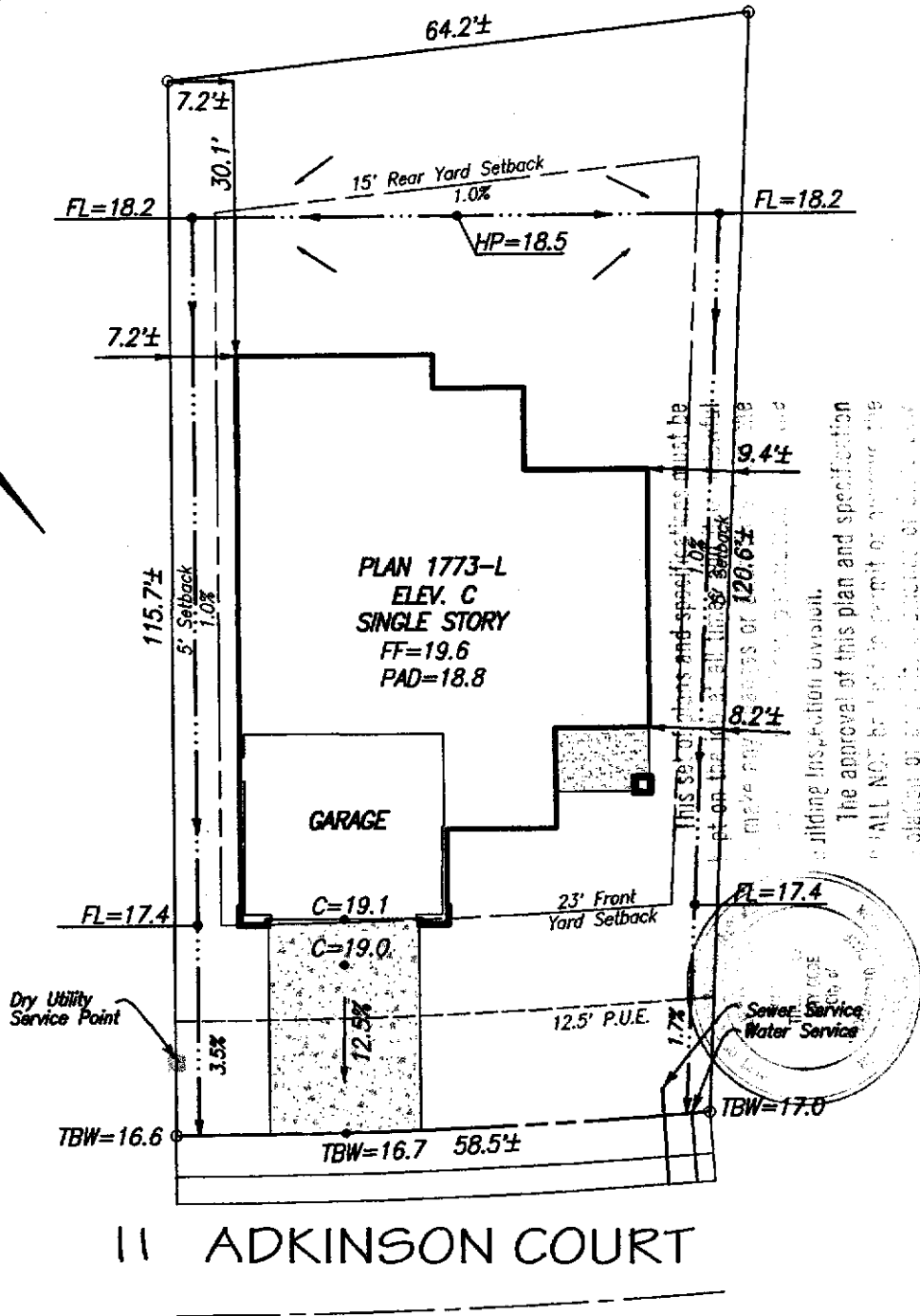
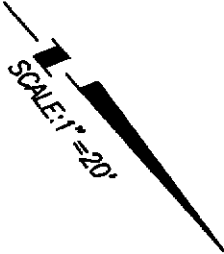
LITS 275 & 270 FTG @ GARAGE REPAIR
PLAN 1773



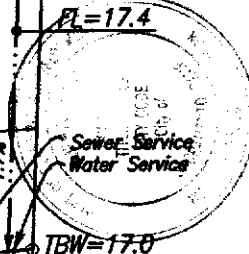
