

RESOLUTION No. 807

Adopted by The Sacramento City Council on date of
November 12, 1937

WHEREAS, a Regular and Special Municipal Election was held in the City of Sacramento on the 2nd day of November, 1937, pursuant to provisions of Article XXI of the City Charter of the City of Sacramento now in force, for the purpose of electing nine (9) members of the City Council of said city to serve for a term of two (2) years beginning January 1, 1938 and ending December 31, 1939; and

WHEREAS, the vote and returns of said election have this day been canvassed by the City Council of the City of Sacramento convening as a Canvassing Board and the results duly ascertained;

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND DECLARED ~~that the aggregate of the votes cast at said election for City Councilmen was 22771~~; that the total number of ballots cast by electors at said election was 22771;

THAT THE TOTAL number of City Councilmen to be elected was nine (9);
