Dear Mayor Isenberg:

As you are aware, the Cities of Roseville, Rocklin, Lincoln and Placer County have been cooperating in joint efforts to study and mitigate the impacts of the Highway 65 By-Pass.

A series of activities were agreed upon by the four South Placer Jurisdictions and accepted by the California Transportation Commission (CTC) as meeting conditions for inclusion of the By-Pass in the 1980 State Transportation Improvement Plan. One of the activities that both the local jurisdictions and the CTC feel is important is coordination with surrounding jurisdictions.

In order to ensure this coordination, the four benefiting jurisdictions have approved a Coordination Agreement that authorizes four ex-officio members from surrounding jurisdictions to serve on the South Placer Policy Committee, the formal body which will coordinate activities of the South Placer Jurisdictions.

The four surrounding jurisdictions authorized to appoint ex-officio members are the City of Auburn, City of Sacramento, Sacramento County and the Sutter-Yuba Jurisdictions as represented by the Intergovernmental Relations Advisory Committee (IRAC).

We invite you to appoint an elected official to serve as your ex-officio representative. Enclosed is a copy of the report presented to the California Transportation Commission, a copy of the South Placer County Study Request for Proposal and a copy of the Coordination Agreement. A full Agenda packet will be sent to your representative at least one week prior to the first meeting which will be held on December 18th at 7:30 P.M. The location has not been determined yet, but it will be somewhere in South Placer County.
