SUBJECT: Metropolitan Arts Division - Request for Increase in Appropriations/
California Arts Council Grant

SUMMARY

This report recommends a \$7,570.52 increase to the FY 1981-82 budget of the Metropolitan Arts Division to reflect funds relating to the Local Organization and Group Development Grant from the California Arts Council.

BACKGROUND INFORMATION

On October 28, 1980, the City Council adopted Resolution No. 80-699 to increase appropriations to the Metropolitan Arts Division by \$17,900 for the purpose of implementing the California Arts Council's Local Organization and Group Development Grant.

FINANCIAL DATA

\$10,329.48 was expended in FY 1980-81 and the balance of \$7,570.52 will be expended in FY 1981-82. There are no indirect costs associated with this grant and it does not require additional City funds. Grant expenditures will be reimbursed from revenues associated with a \$17,900 grant from the California Arts Council.

RECOMMENDATION

It is recommended that the City Council approve the resolution to increase appropriations to the Metropolitan Arts Division by \$7,570.52 for the purpose of continuing the California Arts Council's Local Organization and Group Development Grant.

RESOLUTION AMENDING THE CITY BUDGET FOR FY 1981-82
FOR THE DEPARTMENT OF COMMUNITY SERVICES (METROPOLITAN
ARTS DIVISION - CALIFORNIA ARTS COUNCIL'S
LOCAL ORGANIZATION AND GROUP DEVELOPMENT PROGRAM GRANT)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The continuation of a grant from the California Arts Council for the purpose of Local Organization Group Development requires an appropriation increase for the budget of the Department of Community Services.
2. The City budget for FY 1981-82 is hereby amended:
 - a. By adding thereto the sum of \$7,570.52 to budget 1-01-2281-7238 4258 relating to the expenditure of funds for the purpose stated in paragraph one above.
3. The above appropriation increase is supported by revenue forthcoming from the California Arts Council.
