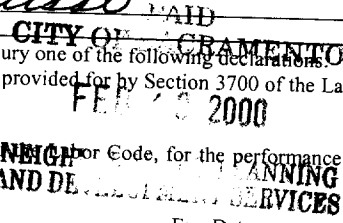

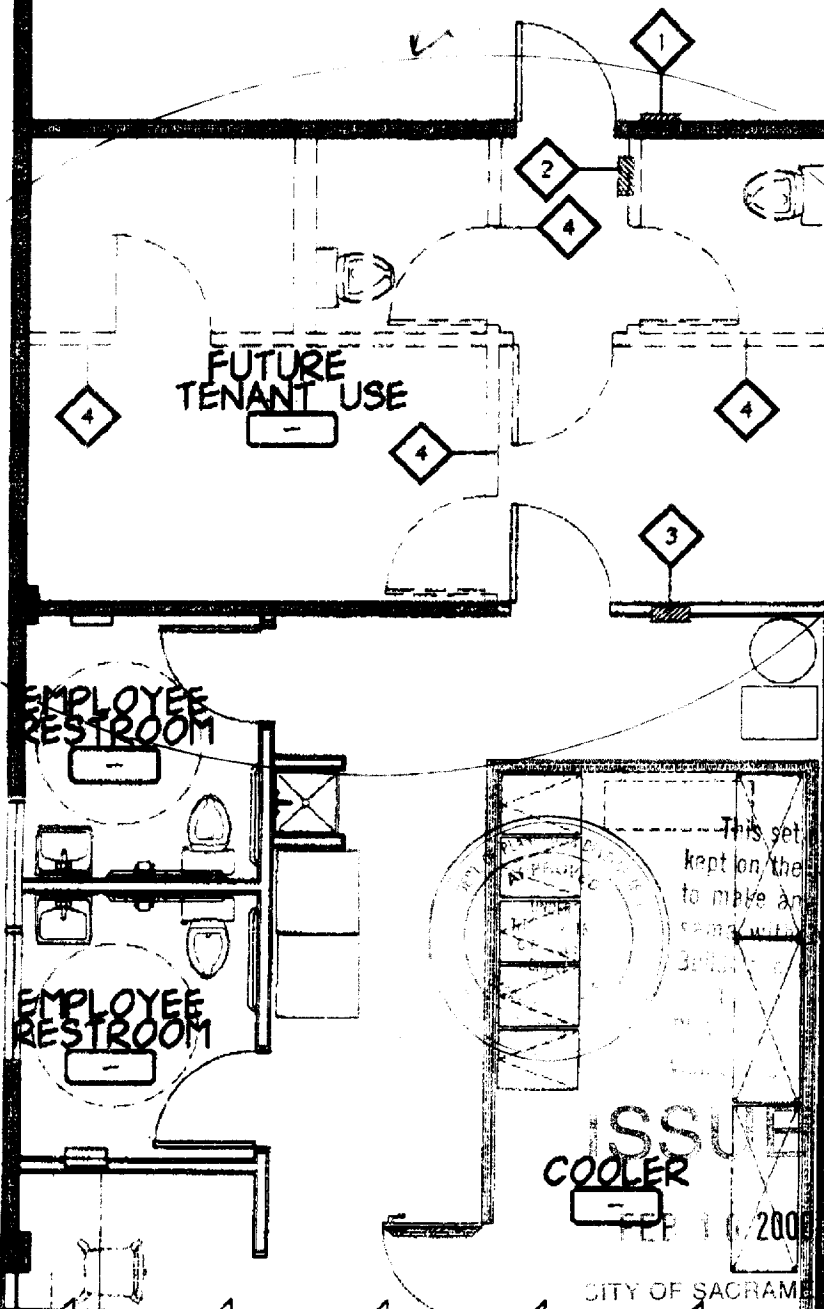

A NEW PLUMBING LAYOUT WILL BE DESIGNED FOR ALL NEW FIXTURES.

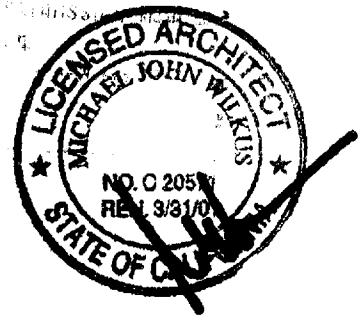

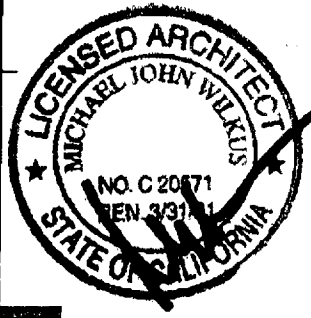
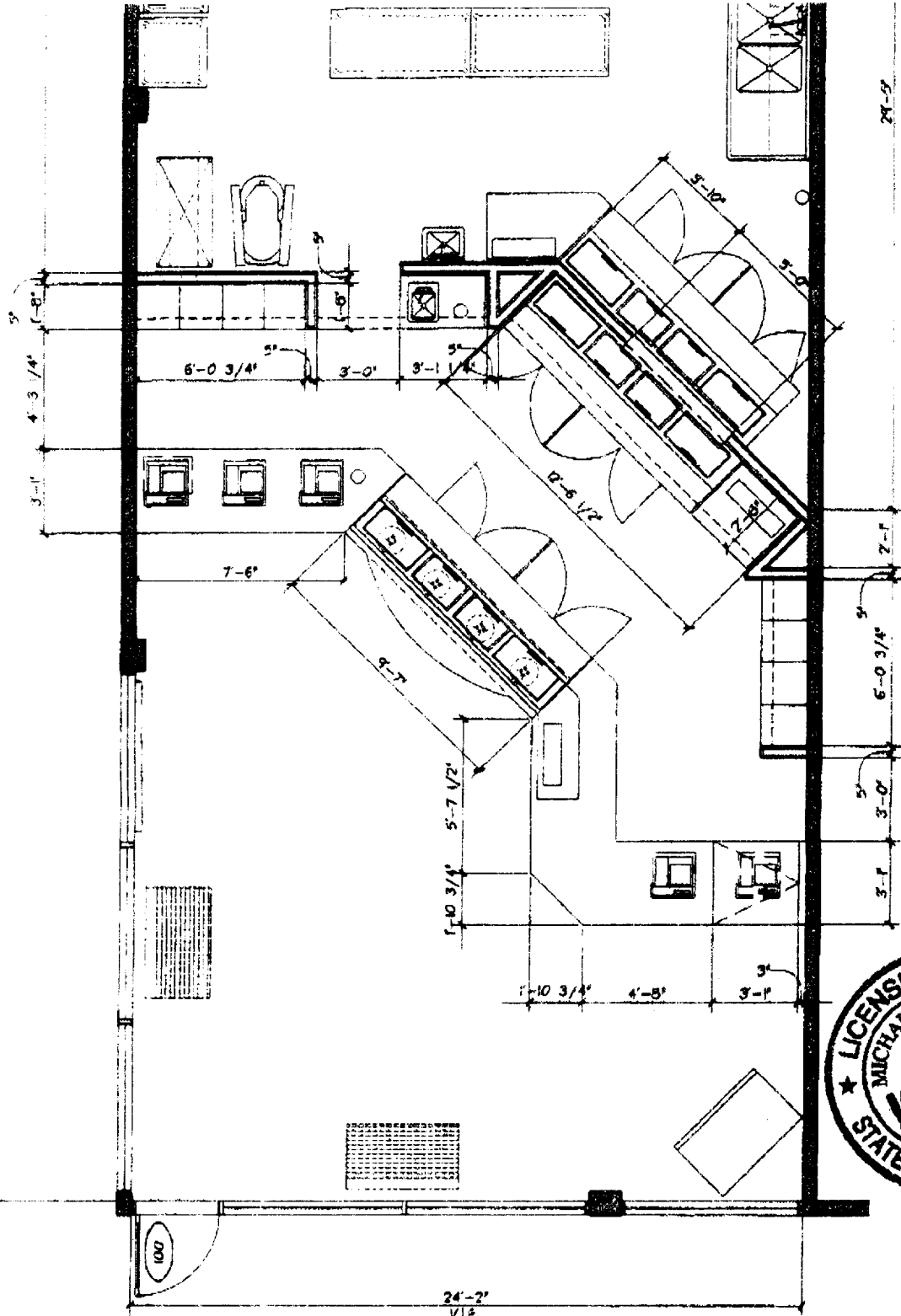
