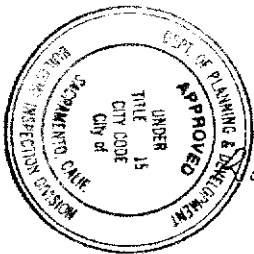

Problem is rotted 8x8 posts for stairs and repair to cut off bottom 1' to 2' of post and insert a new section. The load on these 8" x 8" posts is minimal.

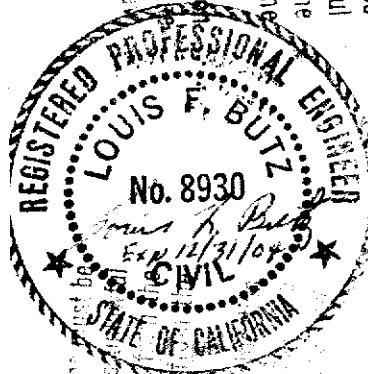
Solution is to saw off damaged section at a right angle and place a new section. The new section shall be tied with a 1/4" x 2" plate 12" Long with 3/8" holes drilled at 1" and 4" from each end. Center trap on joint and secure with 3/8" x 3" Lag screws 4 each in each strap. Straps should be centered on All Four sides of each 8" x 8" post.

All Posts are Full size Rough Sawn

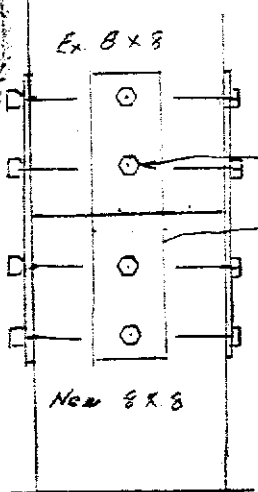

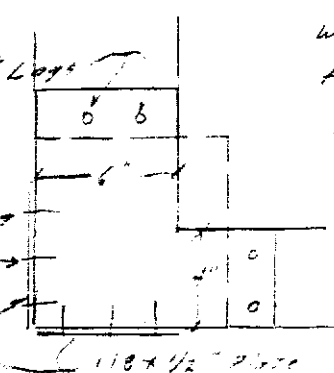

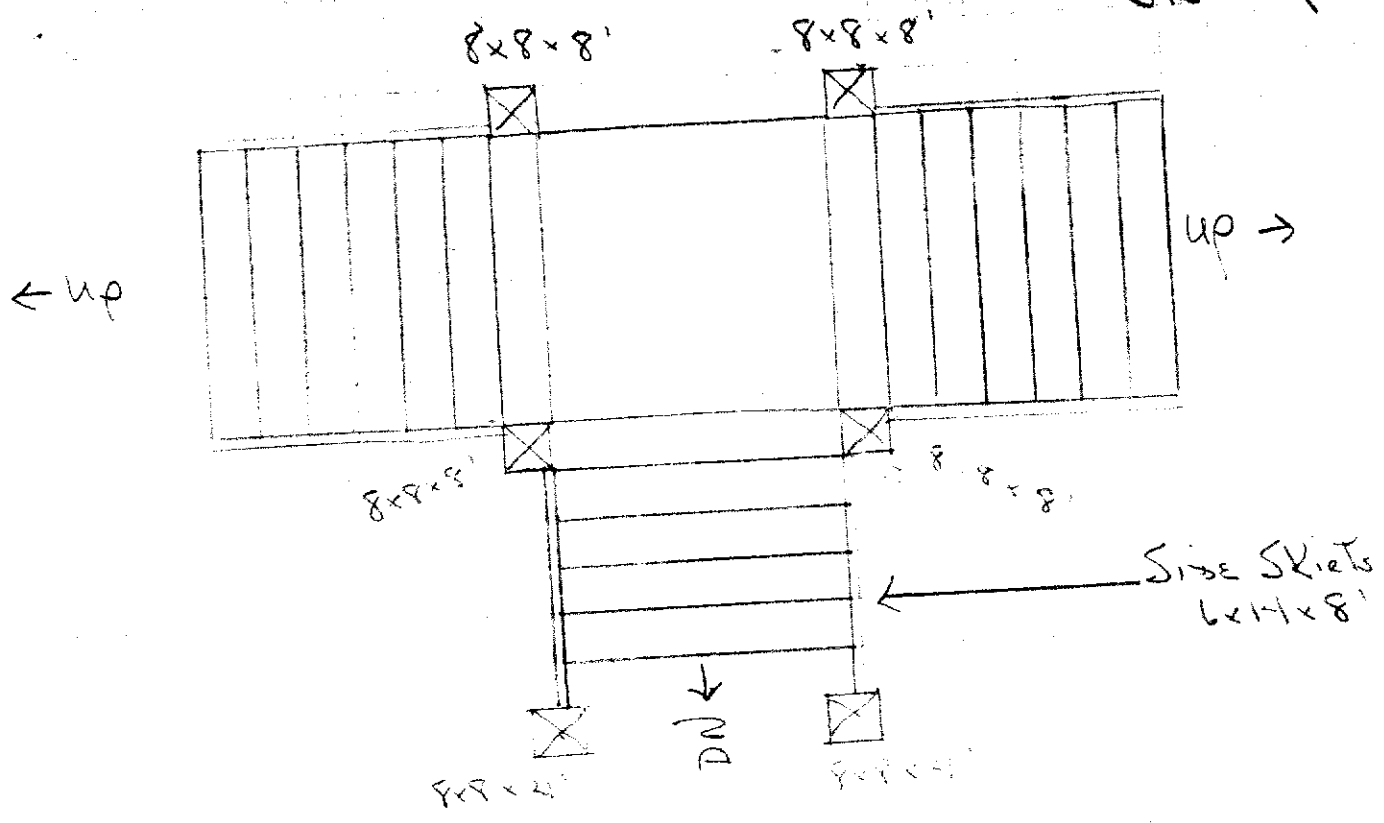
In the event the cut is not True place Tapered shims in the joint to assure uniform bearing.

where long 8x8 posts below balconies are to be replaced use 1/2" plate to extend 2" beyond post and Lag with 2 - 3/8" x 3" Lag screws to beams above. Weld on 1/8" thick x 6" plate to extend down onto outside of 8x8 and secure with 3 - 12Gax 2" screws. Posts and Beams are Full size Rough Sawn

Stairway



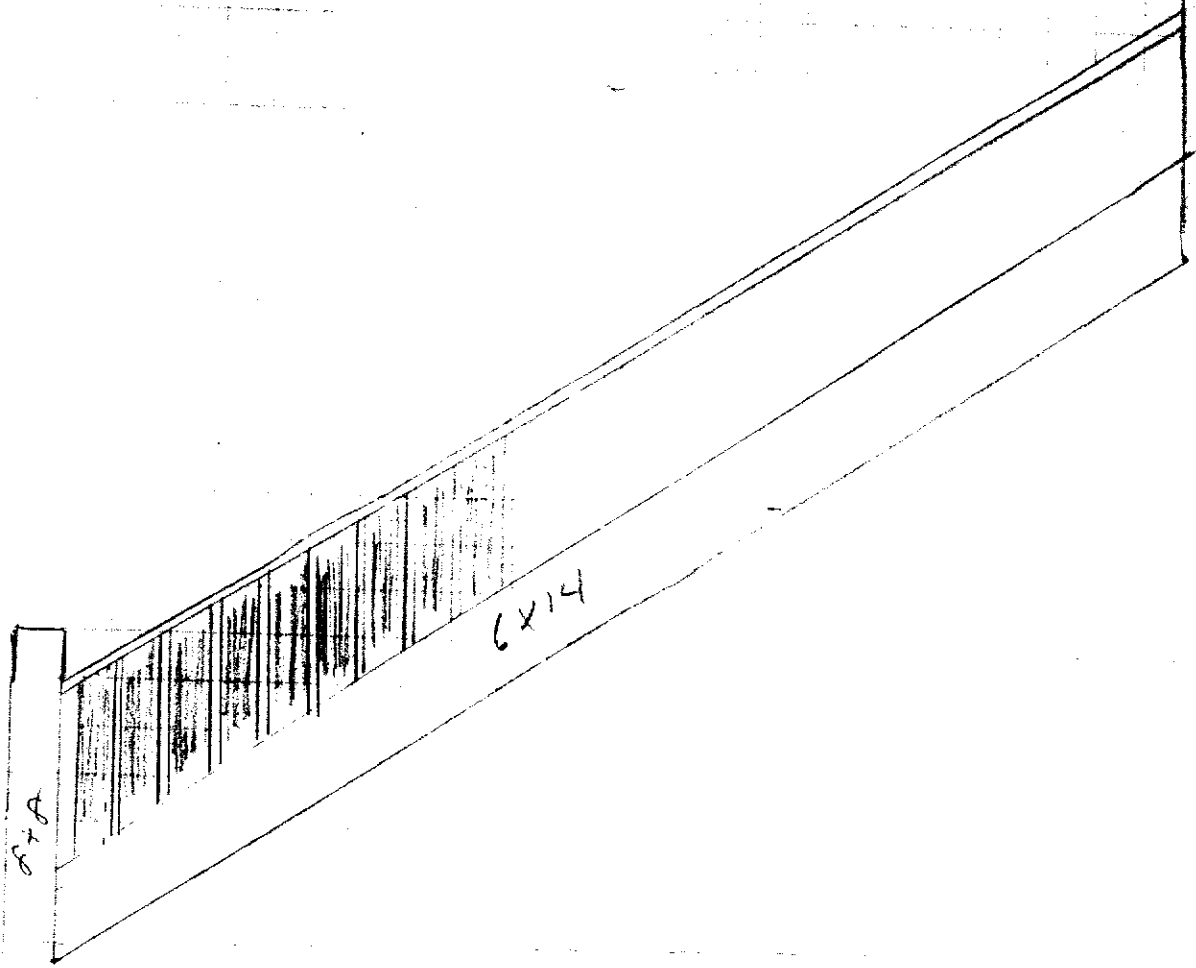

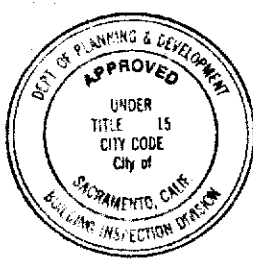
