RESOLUTION ORDERING, PROCLAIMING, CALLING, GIVING NOTICE OF, AND PROVIDING FOR THE HOLDING OF A SPECIAL ELECTION FOR THE PURPOSE OF SUBMITTING TO THE ELECTORS RESIDING IN THE TERRITORY HEREINAFTER PARTICULARLY DESCRIBED, THE QUESTION OF WHETHER SUCH TERRITORY SHALL BE ANNEXED TO; INCORPORATED IN AND MADE A PART OF SAID CITY OF SACRAMENTO, ESTABLISHING ELECTION PRECINCTS THEREFOR, DESIGNATING THE POLLING PLACES THEREIN, AND APPOINTING BOARDS OF ELECTION OFFICERS.

WHEREAS, there has been submitted to said City Council a written petition signed by not less than one-fourth in number of the qualified electors residing within the territory hereinafter described, as shown by the registration of voters of the County of Sacramento, asking that such territory be annexed to the City of Sacramento, a municipal corporation; and

WHEREAS, on Friday, the 5th day of December, 1947, at the hour of 8:00 o'clock p.m. of said day, in the Council Chamber in the City Hall of the City of Sacramento, a hearing was held, at which time any person owning real property within such territory hereinafter described could appear before the said City Council and show cause why said territory should not be so annexed; and

WHEREAS, at the time of said hearing protests and objections to the proposed election were heard and the hearing closed, and the said City Council finds and determines that said protests were not made by owners of a majority of the separate parcels of property within said territory proposed to be annexed as hereinafter described,

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:
