SUBJECT: Schedule of Park Capacity and Uses

SUMMARY

This report recommends that the City Council, by resolution, adopt the attached schedule of park capacity and uses referred to as Exhibit A.

BACKGROUND INFORMATION:

The City Council adopted the existing schedule of park capacity and uses in 1971 by ordinance. This report recommends the adoption of an updated schedule, by resolution, to reflect additional parks and facilities that have been developed since 1971. The change from ordinance to resolution format improves flexibility and reduces time and expense to the City in amending the schedule.

The attached schedule includes the park acreage, open space acreage, assembly capacity, activity capacity, amplified sound restrictions, restroom facilities, and number of off-street parking spaces.

RECOMMENDATION

It is recommended that the City Council, by resolution, adopt the attached schedule of park capacity and uses as set forth in Exhibit A.

(1) Denotes park available for use subject to the issuance of an athletic field permit (Dixieanne, Grant, Renfree Field, Redwood and Stanford).

(2) The portion of Land Park from Riverside Boulevard to 13th Street and 11th Avenue to 13th Avenue, popularly known as the Land Panhandle area, and the portion of McKinley Park from 33rd Street to 35th Street and McKinley Boulevard to Park Way, popularly known as the McKinley Panhandle Area, are not available for amplified sound use permits.

* "Assembly Capacity" denotes maximum number of persons to occupy the park under a park use permit for activities of a passive nature such as concerts, speeches, etc. that occur for the entire period of such use.

** "Activity Capacity" denotes maximum number of persons to occupy the park under a park use permit when activities such as athletic events, court games, etc., occur for part of the period of such use.
