COOPERATION AGREEMENT FOR CENTRAL MAINTENANCE FACILITY

WHEREAS, the United States Department of Housing and Urban Development has agreed to provide funds to the Housing Authority of the County of Sacramento to construct a Central Maintenance Facility to serve units owned and operated by both the Housing Authority of the City of Sacramento and the Housing Authority of the County of Sacramento on the condition that there be a local contribution to the project because ten percent of the units to be served by the facility are not federally subsidized; and

WHEREAS, all the non-subsidized units belong to the Housing Authority of the City of Sacramento; and

WHEREAS, the Housing Authority of the City of Sacramento wishes to cooperate in the construction of the Central Maintenance Facility.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSING AUTHORITY OF THE CITY OF SACRAMENTO:

Section 1. The Authority hereby consents to the construction of the Central Maintenance Facility by the Housing Authority of the County of Sacramento within the jurisdiction of the Housing Authority of the City of Sacramento, to serve housing units owned and operated by the Housing Authority of the City of Sacramento and the Housing Authority of the County of Sacramento.

Section 2. The Executive Director is authorized to enter into the Cooperation Agreement with the Housing Authority of the County of Sacramento, the Redevelopment Agency of the City of Sacramento and the City of Sacramento, attached hereto as Attachment 1.

Section 3. The Executive Director is authorized to reimburse the Redevelopment Agency of the City of Sacramento for an amount not to exceed Three Hundred Eighty-Nine Thousand Five Hundred Twenty-Eight Dollars (\$389,528.00), which the Redevelopment Agency will advance to the Housing Authority of the County

of Sacramento to use as the local contribution to pay construction cost of the Central Maintenance Facility. Such repayment shall be made over a four year period, with no interest, based on the availability of Local Housing Funds so as not to create a negative impact on the operations of such local housing projects.

Section 4. The Executive Director is authorized to convey approximately 2.22 acres of real property described in Exhibit "A" of said Cooperation Agreement (Attachment 1 herein) from the Housing Authority of the City of Sacramento to the Housing Authority of the County of Sacramento, to be used as the site of the Central Maintenance Facility.

COOPERATION AGREEMENT

THIS AGREEMENT, entered into as of this _____ day of _____, 1983, by and between the HOUSING AUTHORITY OF THE COUNTY OF SACRAMENTO (hereinafter "County Authority"), the HOUSING AUTHORITY OF THE CITY OF SACRAMENTO (hereinafter "City Authority"), the REDEVELOPMENT AGENCY OF THE CITY OF SACRAMENTO (hereinafter "Agency"), and the CITY OF SACRAMENTO (hereinafter "City").

WITNESSETH:

WHEREAS, the United States Department of Housing and Urban Development (hereinafter "HUD") has made funds available to the County Authority for construction of a centralized maintenance facility (hereinafter "Facility") to serve all housing owned and operated by the City Authority and the County Authority; and

WHEREAS, ten percent of the housing units to be served by the Facility are not subsidized by HUD, and so as a condition of providing construction funding, HUD has required the County Authority to pay for ten percent of the construction costs; and

WHEREAS, all the units which are not subsidized by HUD are owned by City Authority; and

WHEREAS, on December 22, 1981 by Resolution No. HA 81-112 the City Authority tentatively approved the use of the property described herein in Exhibit "A" (hereinafter "Bannon Street Property") as the site for the Facility; and

WHEREAS, it has been determined that the property owned by City, described herein in Exhibit "B" (hereinafter "City Property") is needed to provide parking, access and circulation space for the Facility.

NOW, THEREFORE, the parties hereto agree as follows:

1. County Authority shall build the Facility on the Bannon Street Property and on the City Property to serve housing units owned and operated by the City Authority and the County Authority.

2. City Authority consents to the construction of the Facility by County Authority within City Authority's jurisdiction.

3. City Authority shall convey the Bannon Street Property to County Authority.

4. City shall convey title to the City Property to the County Authority for Sixty Thousand Three Hundred and NO/100 Dollars (\$60,300.00).

5. Agency shall contribute Three Hundred Eighty-Nine Thousand Five Hundred Twenty-Eight and NO/100 Dollars (\$329,528.00) of Emergency Reserve funds to County Authority. Said funds shall be used by County Authority to pay for construction of the Facility and shall serve as the local contribution required by HUD.

6. City Authority agrees to reimburse Agency in the amount of Three Hundred Eighty-Nine Thousand Five Hundred Twenty-Eight and NO/100 Dollars (\$329,528.00) which Agency contributed to County Authority. Said reimbursement shall be made over a four (4) year period with no interest based upon the annual availability of local housing funds generated by the Alkali Flat Elderly, Oak Park Duplexes, Midtown Manor, and eight scattered sites projects operated by the City Authority.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement as of the date first above written.

Beginning at a 5/8 inch steel rod set in concrete marking the Northeast corner of that certain tract of land deeded to the City of Sacramento in the deed recorded in Book 542 of Deeds at page 167, Sacramento County Records; thence North 89° 41' 50" East 140.20 feet; thence South 00° 18' 10" East 175.00 feet; thence North 89° 41' 50" East 59.80 feet; thence North 00° 18' 10" West 13.86 feet; thence North 89° 41' 50" East 170.34 feet to a point on the West line of Bannon Street; thence along the said West line of Bannon Street, South 00° 07' 03" West 50.00 feet; thence North 89° 52' 57" West 23.75 feet; thence North 77° 52' 55" West 57.42 feet; thence along the arc of a tangent curve to the left, concave to the South, having a central angle of 25° 36' 50", a radius of 100.00 feet and the chord of which bears South 89° 18' 40" West 44.33 feet; thence South 76° 30' 15" West 20.00 feet; thence along the arc of a tangent curve to the left, concave to the Southeast having a central angle of 85° 48' 51", a radius of 100.00 feet and the chord of which bears South 33° 35' 50" West 136.16 feet; thence South 09° 18' 36" East 145.71 feet; thence along the arc of a tangent curve to the right, concave to the West, having a central angle of 27° 39' 33", a radius of 190.00 feet and the chord of which bears South 04° 31' 10" West 90.83 feet; thence South 18° 20' 57" West 39.35 feet to a point on the Northerly line of North B Street; thence along the said Northerly line of North B Street, North 71° 30' 39" West 161.61 feet to a point on the East line of said land deeded to the City of Sacramento; thence along said East line of the land deeded to the City of Sacramento, North 00° 18' 10" West 536.14 feet to the point of beginning.
