TENANT IMPROVEMENT LOAN FOR THE NORTH POINT BUSINESS PARK

BE IT RESOLVED BY THE REDEVELOPMENT AGENCY OF THE CITY
OF SACRAMENTO:

Section 1: The Executive Director is authorized to execute a loan agreement with Pacific Group, Ltd., to cover part of the cost of providing tenant improvements for Golden State Cellular. The loan agreement shall be in a form approved by the Agency Counsel, and shall provide at a minimum:


- (a) A maximum loan amount of \$20,000;
- (b) An interest rate of six percent;
- (c) A note which is due and payable in eight years;
- (d) A third deed of trust on the subject property as security;
- (e) A provision that disbursements will be made only to pay for completion of tenant improvements for Golden State Cellular;
- (f) Any other provisions which in the opinion of Agency Counsel are necessary to assure appropriate use of loan funds and repayment of such funds to the Agency.

Section 2: Prior to execution of the loan agreement, Agency staff shall complete a review of the partnership credit worthiness.
