### **Description/Analysis**

**BACKGROUND**

- A. Chapter 12(B)(a) of the City Council's adopted Rules of Procedure call for the Mayor's appointment, with approval of the Council, of Councilmembers to serve on Council standing committees. These committees are the Law & Legislation Committee, Audit Committee and Personnel and Public Employees Committee.
- B. Chapter 12(D)(1) of the City Council's adopted Rules of Procedure call for the Mayor's appointment, with approval of the Council, of Councilmembers to serve on various regional authorities, agencies and committees.

- Section 2. The City of Sacramento declares that Councilmembers Steve Cohn, Raymond Tretheway, Lauren Hammond and Robbie Waters shall serve on the Audit Committee and that Councilmember Steve Cohn shall act as chair.
- Section 3. The City of Sacramento declares that Councilmembers Raymond Tretheway, Robert King Fong, Kevin McCarty and Bonnie Pannell shall serve on the Personnel & Public Employees Committee and that Councilmember Tretheway shall act as chair.
- Section 4. The City of Sacramento declares that the Mayor and Councilmembers shall serve on the following regional authorities, agencies and committees as indicated on the attached roster as primary representatives or alternates where applicable.

**RESOLUTION NO.**

**ADOPTED BY THE SACRAMENTO CITY COUNCIL**

**CONFIRM APPOINTMENT OF CITY COUNCILMEMBERS TO SERVE AS THE CITY OF SACRAMENTO REPRESENTATIVES ON THE SACRAMENTO REGIONAL COUNTY SANITATION DISTRICT (SRCSD) AND THE SACRAMENTO AREA DISTRICT SEWER BOARD (FORMERLY KNOWN AS CSD-1) BOARDS OF DIRECTORS, AND APPOINTING ALTERNATE REPRESENTATIVES TO SERVE IN THEIR ABSENCE**

**BACKGROUND**

- A. The Sacramento region is changing and new cities are being formed, populations and demographics are shifting, and annexations are occurring- all of which effect the composition of various regional boards, including the SRCSD's Board.
- B. The Districts are governed by Boards comprised of representatives from the respective governing bodies of the jurisdictions served by SRCSD and the Sacramento Area Sewer District Board.
- C. The Health and Safety Code, Sections 4730.11 and 4730.12 were added by SB 1663 to expand the composition of the SRCSD Board based on population.
- D. Each City Council must designate (by a vote) the member(s) of their Council to become a director on the SRCSD Board and Sacramento Area Sewer District Board, as well as specifying alternates.
- E. On January 12, 2010, the Mayor announced, in open session, the appointments to these Boards for 2010.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. The City of Sacramento declares that Councilmembers Sandy Sheedy, Steve Cohn, Robert King Fong, Lauren Hammond and Bonnie Pannell will serve as the City's primary representatives, and that Mayor Kevin Johnson and Councilmembers Raymond Tretheway, Kevin McCarty and Robbie Waters will serve as alternate representatives on the SRCSD

Board of Directors; and

Section 2. Councilmember Lauren Hammond will also serve as the Sacramento Area Sewer District Board primary representative, and that Councilmember Bonnie Pannell shall serve as the alternate representative to the Sacramento Area Sewer District Board.
