SUBJECT: Resolution Authorizing Execution of Agreement Between The Spink Corporation and the City of Sacramento for the Preparation of Improvement Plans for Frates Ranch Unit No. 3

SUMMARY:

Presented herewith for approval is a consultant services agreement for an amount not to exceed \$51,870 between The Spink Corporation and the City of Sacramento for the preparation of engineering design and development for public improvement of Frates Ranch Unit No. 3.

BACKGROUND INFORMATION:

This agreement is presented to conform to the guidelines of the policy for Retention of Professional Consultants for City Projects adopted May 10, 1977. The charges shall represent hourly charges for personnel involved in the work, materials, supplies, stakes, mileage and prints needed in the work process, with the total fee not to exceed \$51,870. This fee is about 3.8% of the estimated construction cost of \$1,365,000.

FINANCIAL DATA:

Chapter 38 of the City Code sets forth the fees charged by the City for engineering services for public improvements within the City of Sacramento. This fee is customarily collected in two payments; one half of the fee before design work is commenced and the other half of the fee prior to the start of construction. The City was paid \$62,475 on January 24, 1980, as an advancement by the developer for the design work for Frates Ranch Unit No. 3.

RECOMMENDATION:

It is recommended that the City Manager and City Clerk be authorized to execute the subject agreement by passage of the attached resolution.
