This letter is written in response to a field question you brought to our attention on Tuesday Dec. 26, 2000. The question and our response are listed below:


You asked us if Boise Cascade products could be used in lieu of Truss Joist MacMillian products, which we call out on the plans. After comparing the products of the two different floor systems we do approve of using BCI's in place of TJI's:

11 7/8" BCI 400 instead of 11 7/8" TJI Pro150

Although we would like to note that BCI's are weaker than TJI's and may cause greater deflection than our recommendation. They do meet all the UBC's requirements.

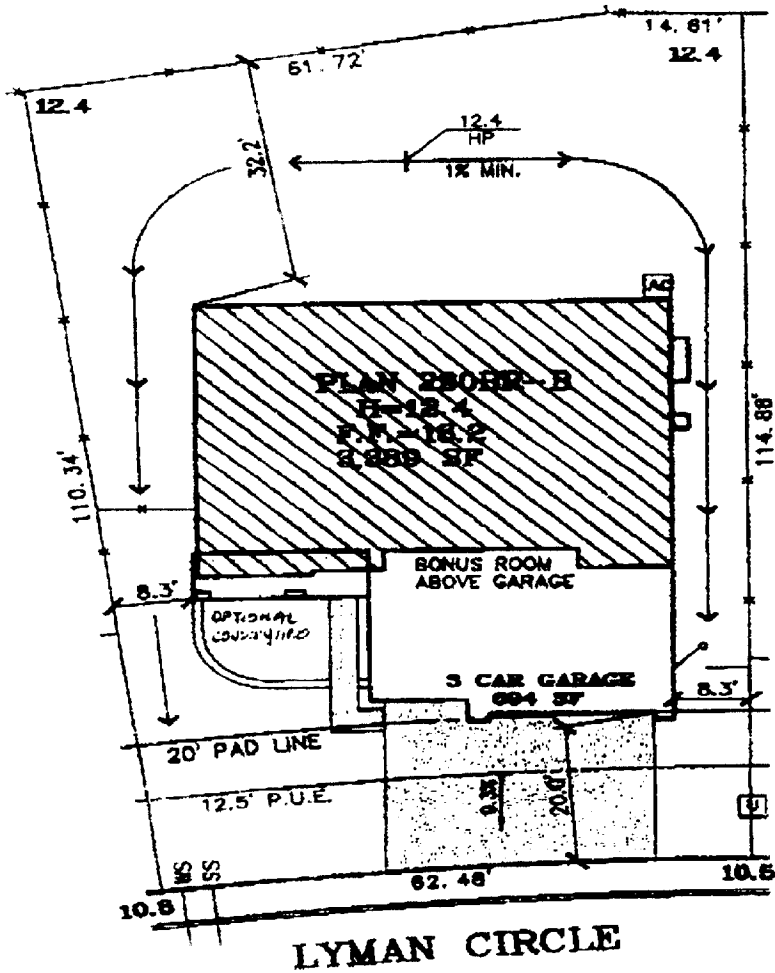
