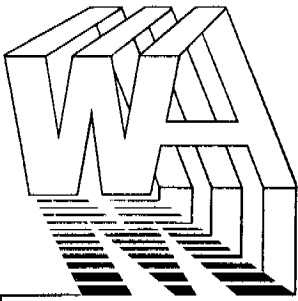

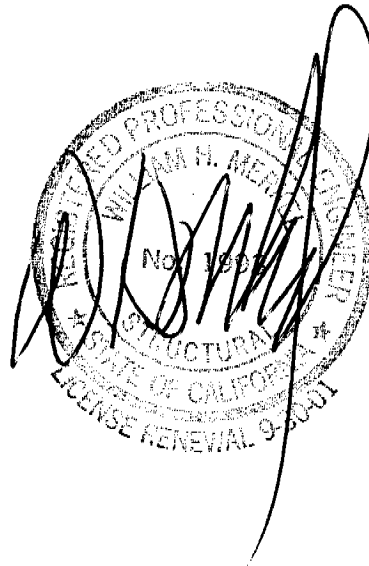

The 2x8 roof joists @ front of garage area of building with birdsmouth notch @ bearing to beam leaving 5" of member measured from inside face of beam to inside face of roof sheathing is o.k. by inspection. Structural calculations call for 2x6 roof joists @ 24" o.c.; allowable shear is 118.75 psi vs. applied shear of 47.51 psi.

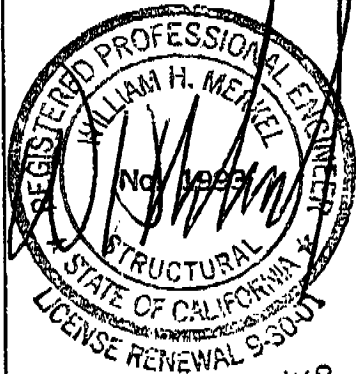
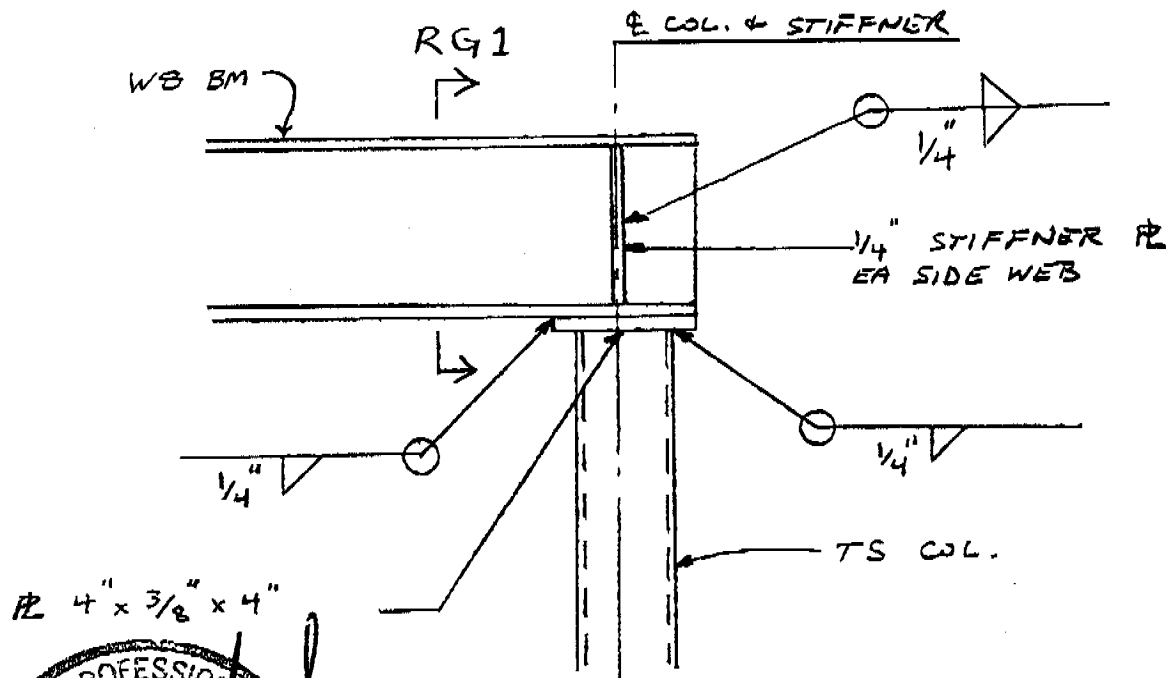

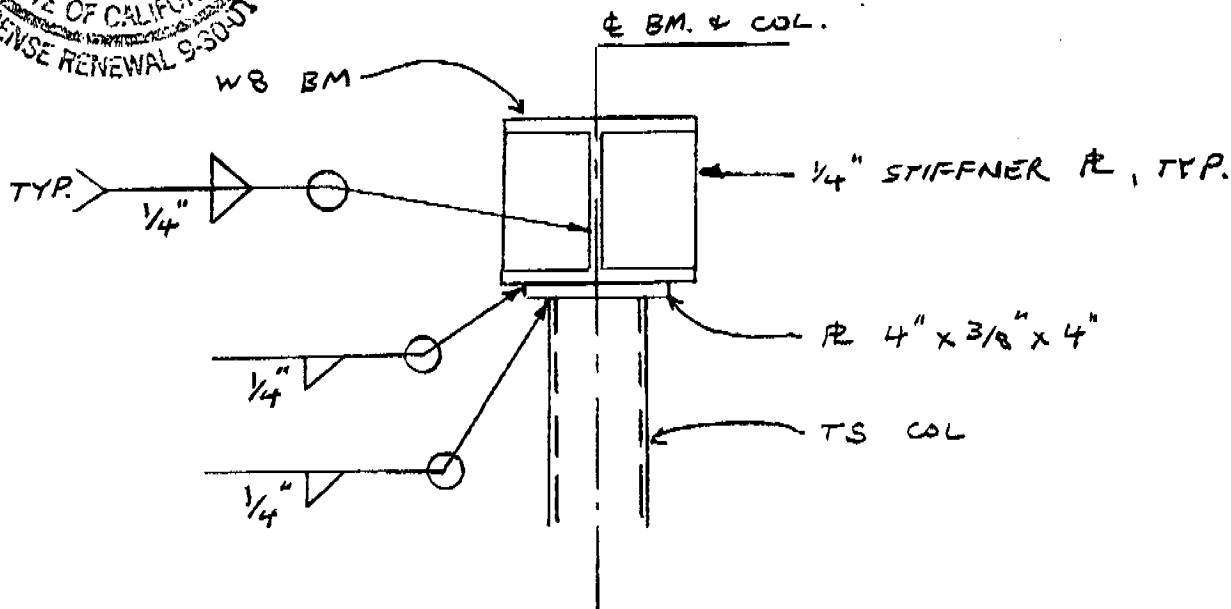
