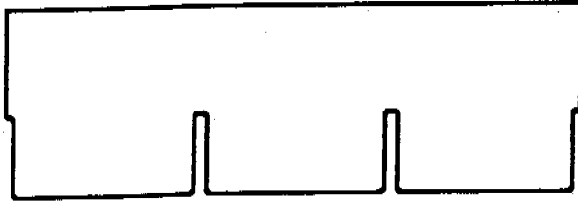

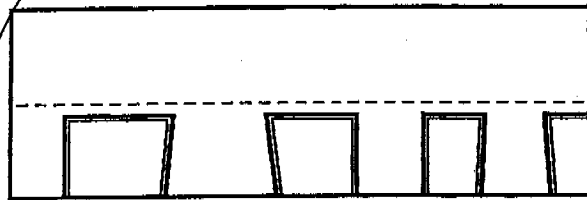

COMPOSITION ROOFING MATERIALS

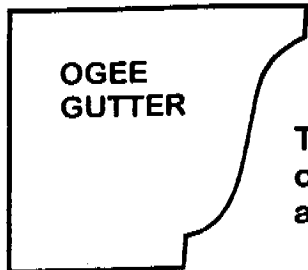


Three-tab NOT ALLOWED
in Design Review Areas



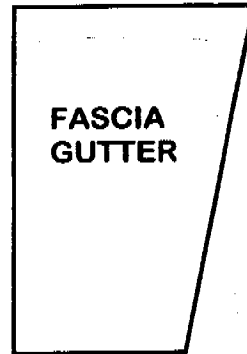

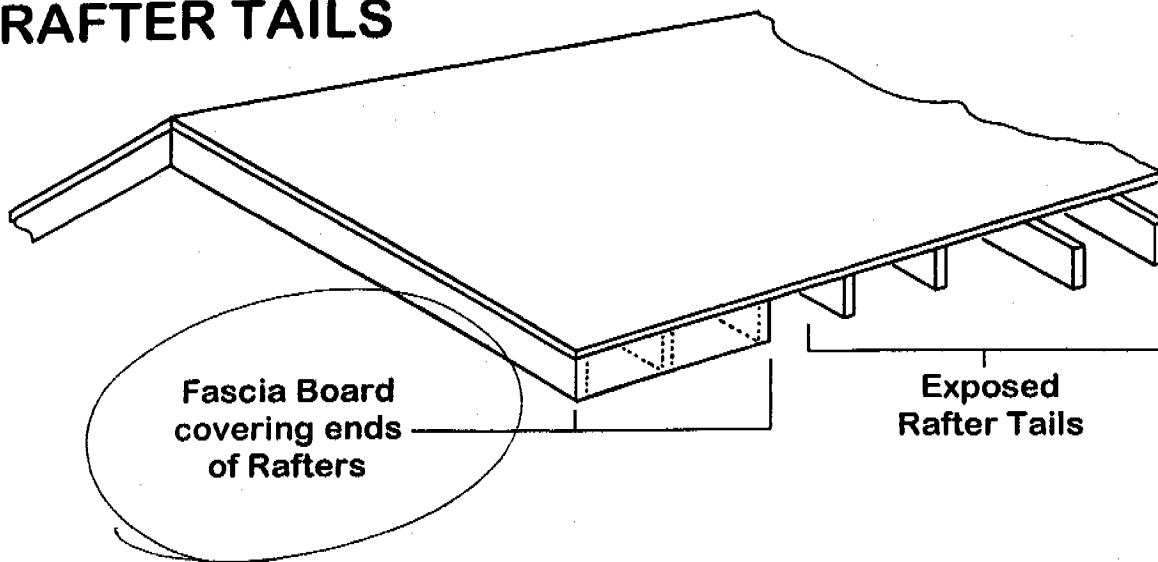
