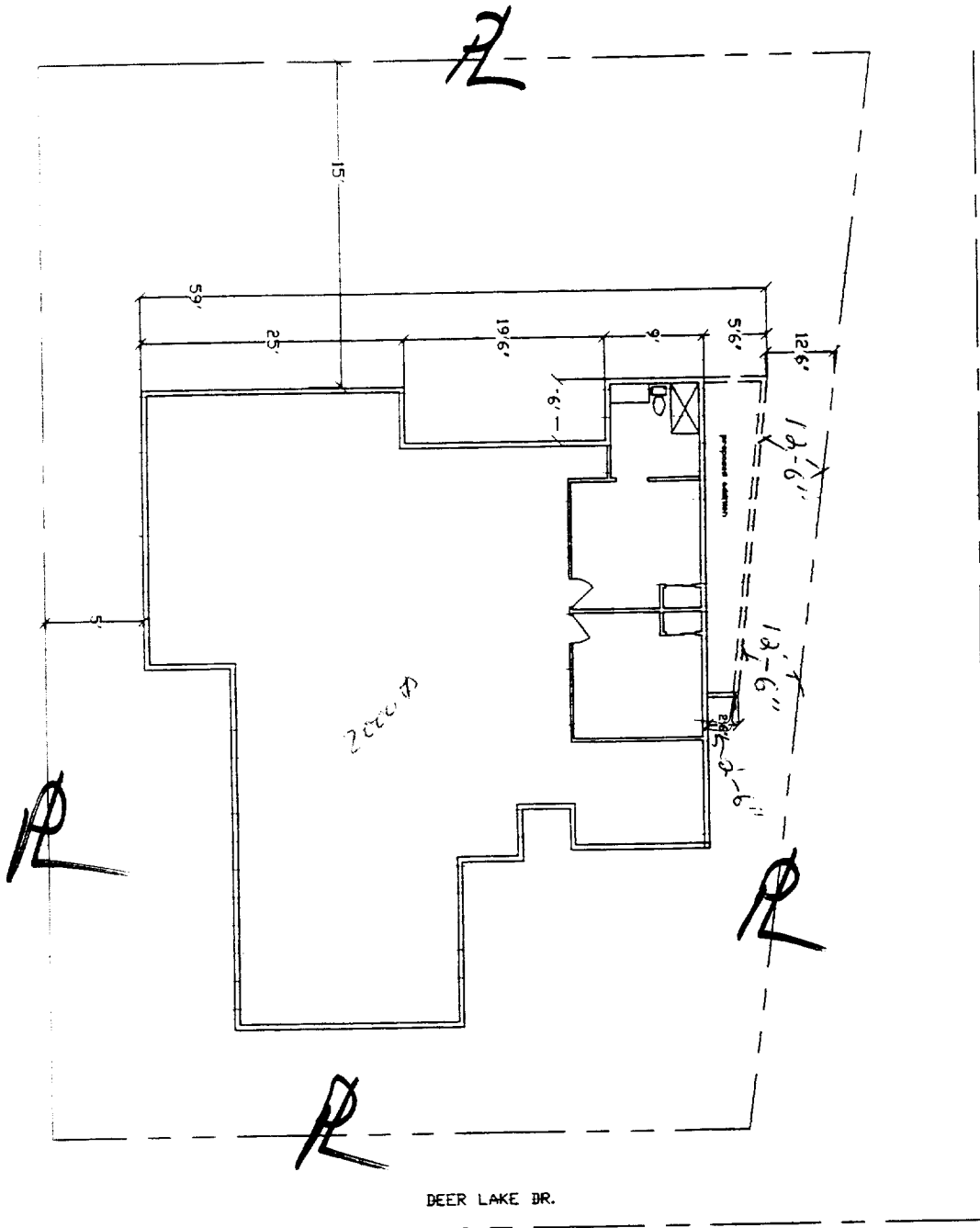
Floor Plan

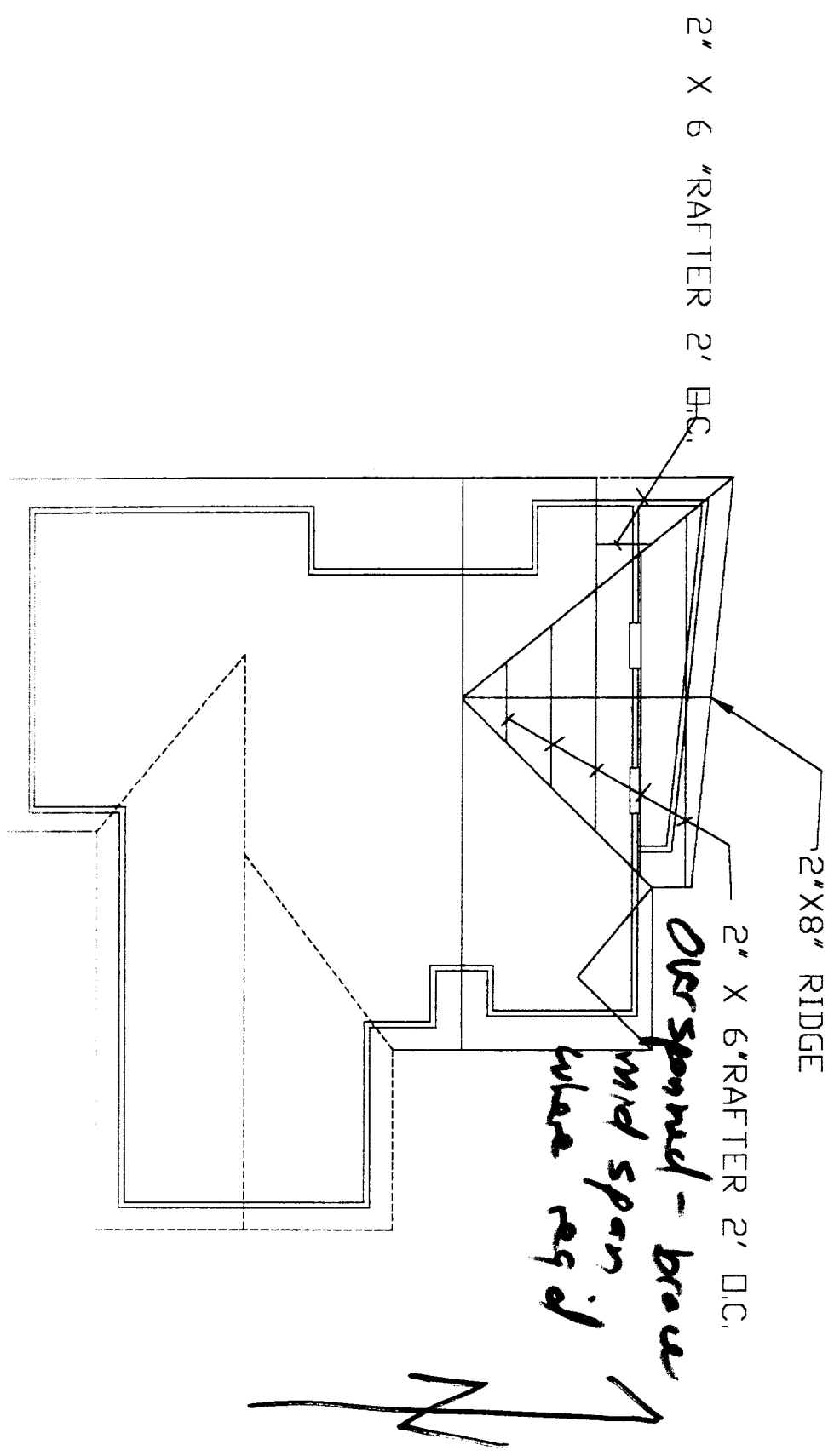

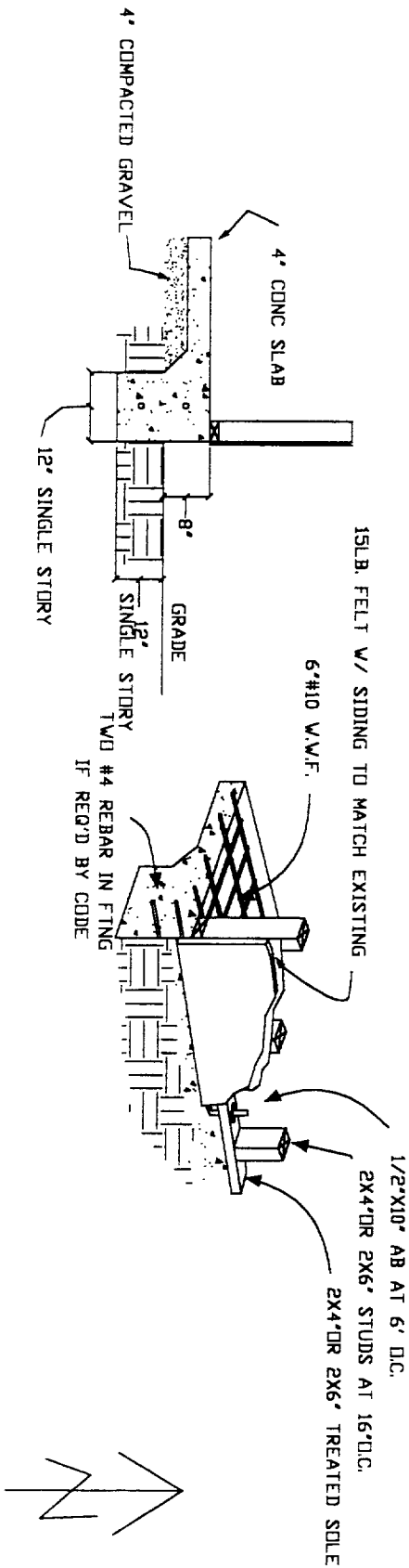

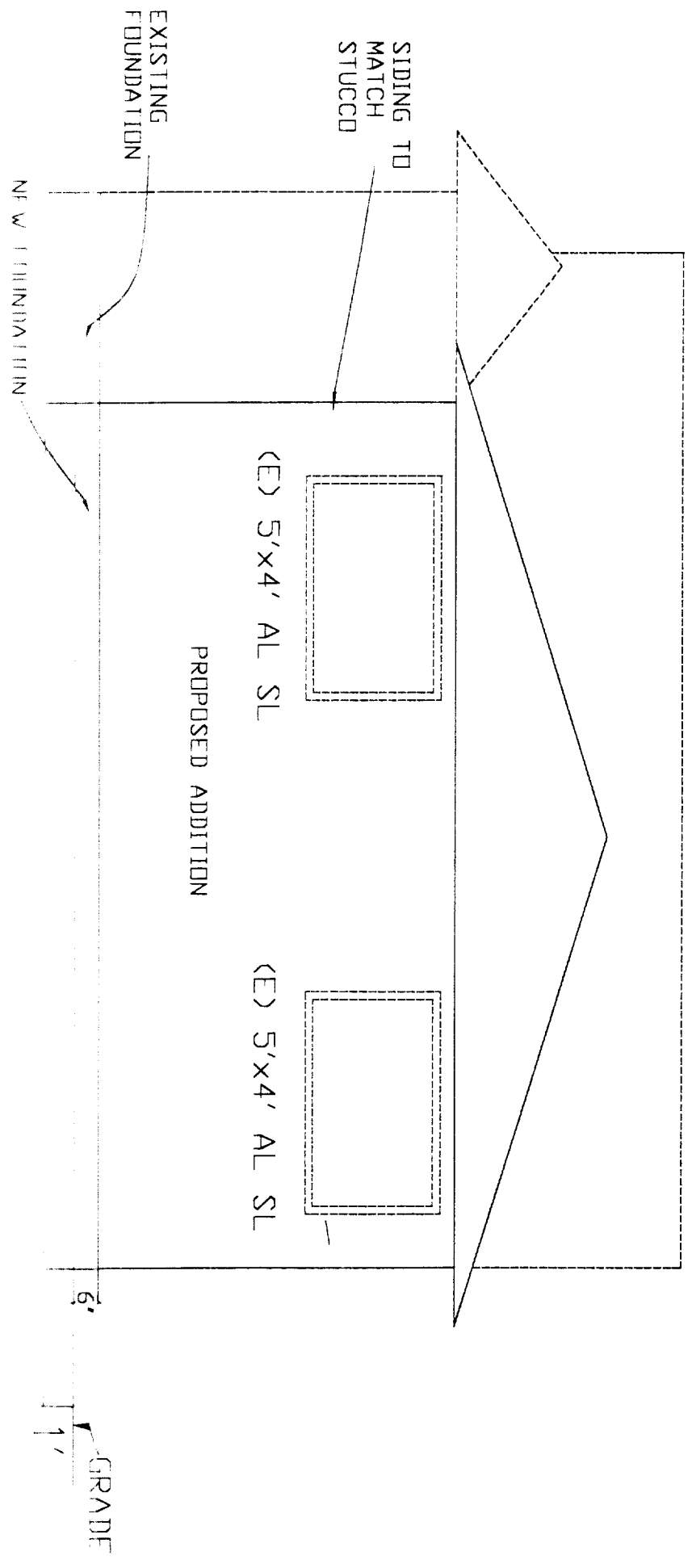


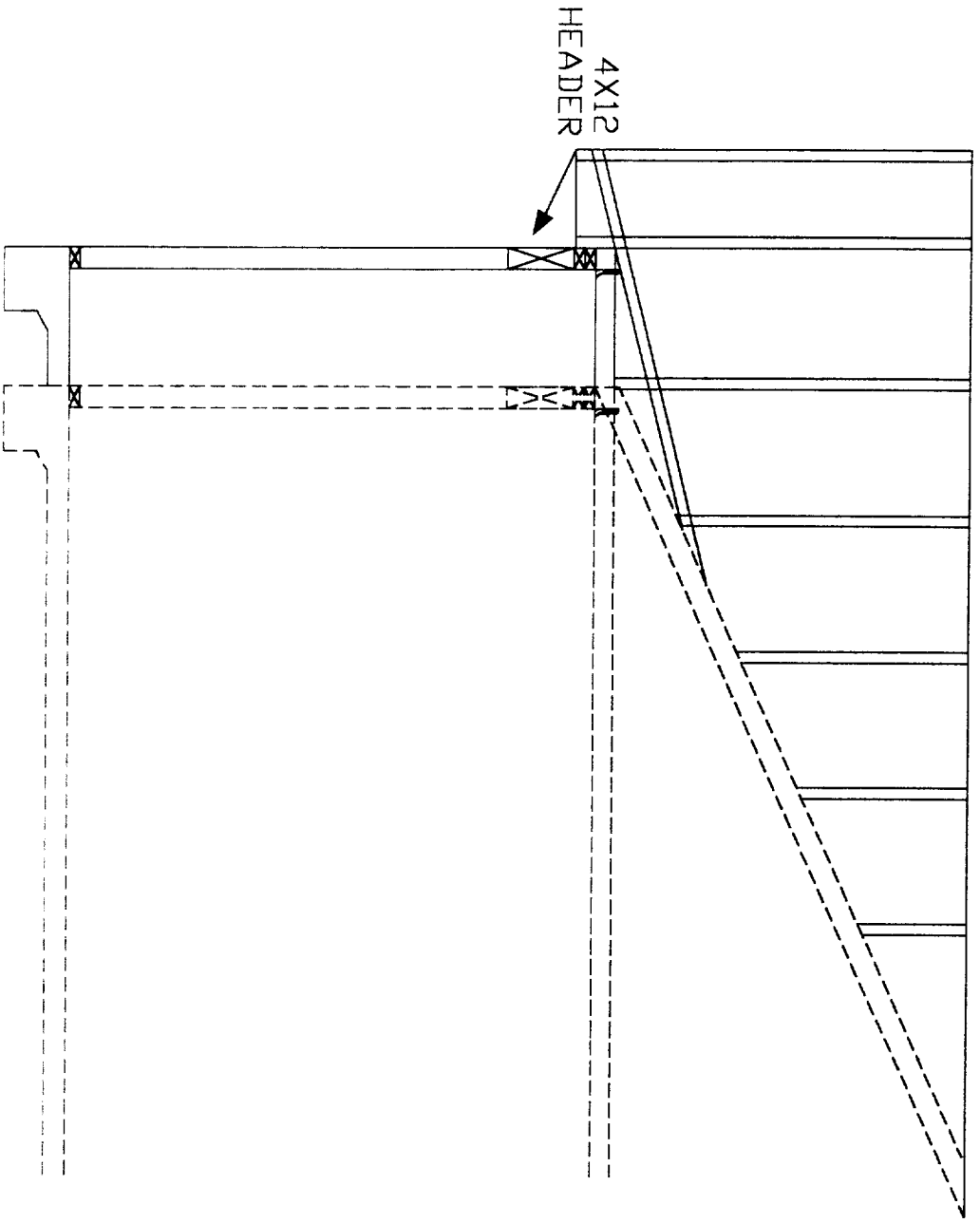
EXTERIOR WALL AND SLAB DETAIL
