

RESOLUTION NO. 581

Adopted by The Sacramento City Council on date of

February 10, 1939.

A RESOLUTION PROVIDING FOR THE HOLDING OF A SPECIAL MUNICIPAL ELECTION IN THE CITY OF SACRAMENTO ON TUESDAY, MARCH 28, 1939, FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED ELECTORS OF SAID CITY A PROPOSAL TO AMEND SECTION 73 OF THE CHARTER OF SAID CITY; ESTABLISHING ELECTION PRECINCTS AND POLLING PLACES FOR SAID SPECIAL ELECTION AND APPOINTING BOARDS OF ELECTION THEREFOR, AND PROVIDING FOR AND DIRECTING PUBLICATION OF NOTICE AND PROCLAMATION OF SAID SPECIAL ELECTION.

WHEREAS, the City Council of the City of Sacramento proposes to submit on its own motion to the qualified electors of said City a proposal to amend Section 73 of the Charter of said City and has caused said proposed amendment to be published in THE SACRAMENTO UNION, the official newspaper of said City, which publication and advertisement was completed on February 6th, 1939; and

WHEREAS, it is advisable that provision be made for the conduct and holding of said special municipal election,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO, as follows:

1. - That a special municipal election in and for the City of Sacramento is hereby called and shall be held on Tuesday, March 28, 1939, for the object and purpose of submitting to the qualified electors of the City of Sacramento the following proposal to amend Section 73 of the Charter of the City of Sacramento, as follows, to wit:

PROPOSAL NO. 1

To amend Section 73 of the Charter of the City of Sacramento as follows:

"Fiscal Year

Sec. 73. The City Council is hereby authorized to fix and determine the fiscal year of the City and to change the same from time to time as need may arise."

2. - That for the purpose of said special municipal election, the City of Sacramento is hereby divided into Seventy-one ( 71 ) election precincts, to be numbered 1 to 71, inclusive. That each of said precincts shall consist of a general election precinct or a consolidation of two or more general election precincts as now established of record for general state and county election purposes by orders of the Board of Supervisors of Sacramento County now on file in the office of the County Clerk of said County of Sacramento, which are hereby referred to and by reference incorporated herein; and the boundaries of all of said municipal election precincts established for said special municipal election hereby called (except in the case of consolidated precincts) shall consist of the identical boundaries of the general election precincts fixed by orders of the Board of Supervisors of Sacramento County fixing and determining the boundaries of such general election precincts for general state and county election purposes, as the same are now on file and of record in the office of the County Clerk of said Sacramento County. That the boundaries of all consolidated special municipal election precincts hereby established shall consist of the boundaries of two or more of said general election precincts hereby consolidated for the purposes of said special municipal election. That said municipal election

precincts, the polling places, and the officers of election thereat shall be, and the same are hereby, designated as more particularly set forth in the form of Official Notice thereof provided in Section 3 of this resolution.

3. - That the City Clerk be, and he is hereby, instructed to publish the list of precincts, polling places and election officers hereby established for the conduct of said special municipal election, in the official newspaper of the City of Sacramento for at least two (2) issues thereof, the last publication of which shall be at least one (1) week prior to the date of said special municipal election. Such notice may be substantially in the following form:

4. - That the polls at the polling places hereinbefore designated shall open at six o'clock A. M. of the day of said election and close at seven o'clock P. M. of the same day; provided, however, that if at the hour of closing there are any other voters at the polling places or in line at the door, who are qualified to vote and have not been able to do so since appearing, the polls shall be kept open a sufficient time to enable them to vote, but no person who shall arrive at the polling place after the time provided for closing the polls shall be entitled to vote although the polls may be open when he arrives.

5. - That the City Clerk is hereby directed to arrange for the necessary voting booths at the polling places hereinbefore specified and to have the necessary ballots printed and to procure suitable ballot boxes and all necessary supplies and materials for conducting said election. That the City Clerk shall cause to be printed sample ballots identical with the ballots to be used at the election, except as to quality and color of paper, and shall mail a copy of the same to each registered voter at least five (5) days before said election.

6. - That all electors of the City of Sacramento qualified in accordance with the provisions of the City Charter

and the general laws of the State of California, shall be entitled to vote at said special municipal election upon the proposed amendment to the Charter of said City to be submitted thereat. That the City Council shall meet on Tuesday, April 4, 1939, to canvass the absentee votes, if any, cast at said election, and shall meet on Thursday, the 6th day of April, 1939, at the City Hall, at eight o'clock P.M. and shall canvass the result of said election.

7. - That said special municipal election hereby called shall be held and conducted, the votes thereat received and canvassed, and the returns thereof made and the result thereof ascertained and determined in accordance with the Charter of the City of Sacramento, and in all particulars not prescribed by said Charter said election shall be held in accordance with the Constitution and general election laws of the State of California. That this resolution shall be deemed supplementary to the provisions of the Charter of said City of Sacramento and the general election laws of the State of California, and the provisions hereof shall be applicable only in so far as the same shall not be in conflict with the provisions of said Charter or the general laws. That no informalities in conducting said special municipal election shall invalidate the same if they have been conducted fairly and in substantial conformity to the requirements of the Charter of the City of Sacramento and the general laws.

8. - The City Clerk is hereby ordered and directed to give notice of the time and place of holding said election, the proposition to be voted upon and the purpose and object of said special election in all respects as required by Section 197 of the Charter of the City of Sacramento.

9. - This resolution shall take effect immediately.
