SUMMARY:

- The proposed resolution will authorize the use of the City of Sacramento Seal on a plaque to be permanently installed inside a KC-135R aircraft which has been chosen to be dedicated as the "Spirit of Sacramento" by the 163rd Air Refueling Wing, of the California Air National Guard of the United States Air Force.

BACKGROUND INFORMATION:

- The "Spirit of Sacramento" has been around the world and proudly represents not only the Air Force, the California Air National Guard, but Sacramento as well. Each aircraft chosen to be dedicated to a city is an active aircraft. On the outside of the

aircraft appears a 'crew box' listing the names of the crew chief and crew members. Above this box appears the name "Spirit of Sacramento". The wing now wishes to place a permanently mounted plaque inside the aircraft with the city seal.

Official dedication ceremonies will be forthcoming in September at which time the aircraft will be brought to Sacramento for formal dedication with the Mayor and Council.

FINANCIAL CONSIDERATIONS:

There is no fiscal impact incurred with this action.

There are no environmental considerations to be applied to this report.


POLICY CONSIDERATIONS:



**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SACRAMENTO, CALIFORNIA, AUTHORIZING USE OF THE

WHEREAS, the City Code, Section 1.01.120 [Unauthorized Use] prohibits use or reproduction of the city seal in any manner provided that the City Council may by resolution permit the use of a reproduction; and

WHEREAS, the 163rd Air Refueling Wing, of the California Air National Guard of the United States Air Force wishes to dedicate a KC-135R aircraft as the "SPIRIT OF SACRAMENTO"; and

WHEREAS, the wing desires to install a permanent plaque inside the aircraft with a replica of the city seal and the name "Spirit of Sacramento";

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO, CALIFORNIA, to authorize the 163rd Air Refueling Wing to have a permanent plaque prepared for installation inside the selected aircraft to be dedicated the "Spirit of Sacramento"; the plaque to contain a replica of the city seal.
