APPLICATION: A. Negative Declaration

B. Rezone from Light Density Multi-Family (R-3A) to Medium Density Multi-Family (R-4)

LOCATION: 520 10th Street

PROPOSAL: The applicant is requesting a rezoning to allow adding two new units to an existing two unit Victorian proposed for renovation.

PROJECT EVALUATION: The applicant previously obtained a variance for waiver of parking from the Planning Commission on August 9, 1984. The applicant also indicated at the August 9th meeting that he will be working with Councilman Shore to obtain the necessary R-4 zoning for the four unit project. The City Council has directed staff to work with the applicant towards rezoning the site.

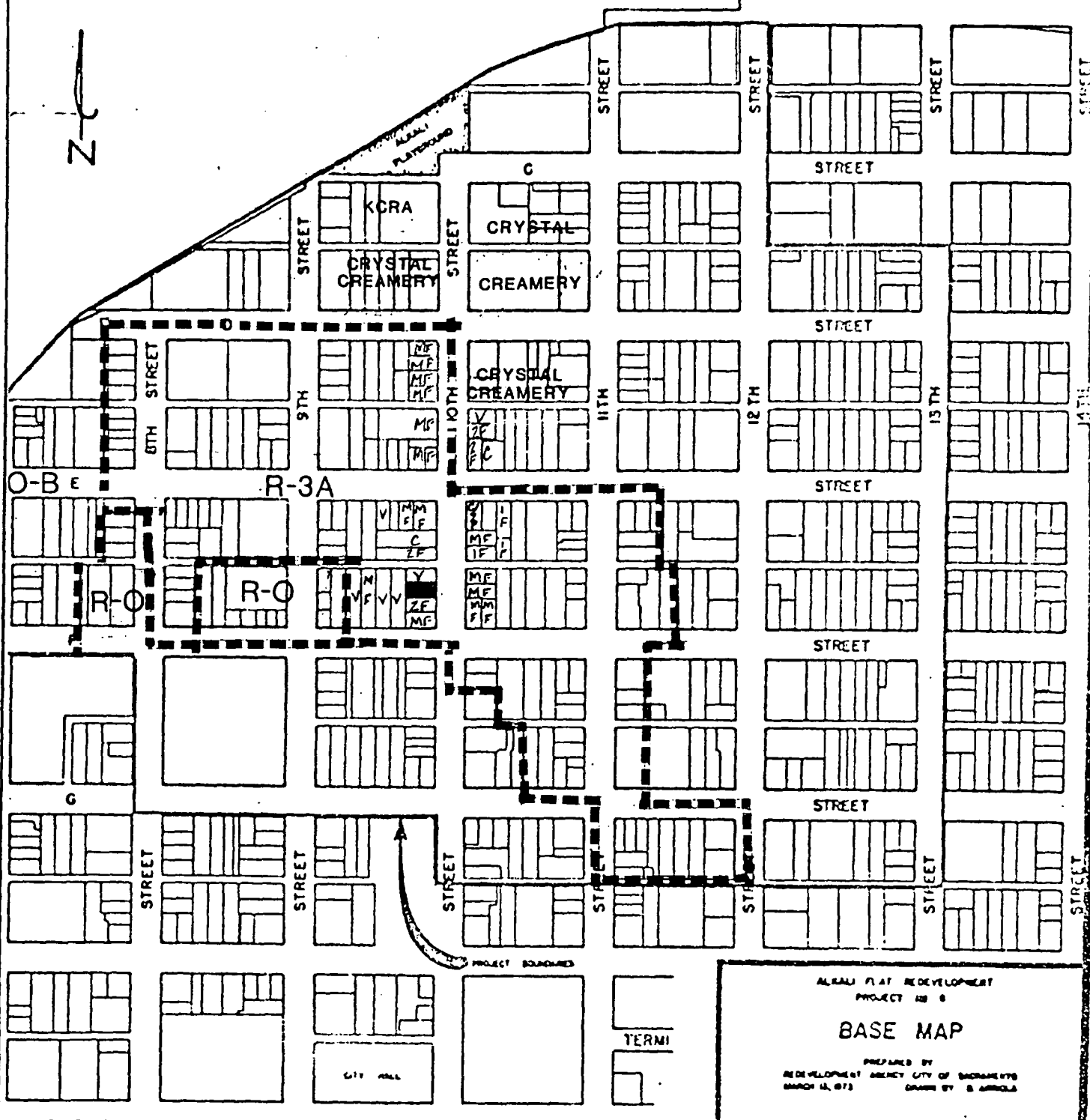
PROJECT EVALUATION: The subject site was rezoned from R-4A to R-3A during the recent project public hearings on the Alkali Flat Redevelopment Plan. The applicant indicated he did not oppose the rezoning since he believed that his project would proceed to a point where it would be "grandfathered" in. This was not the case and a rezoning is now necessary.

The City Council has indicated a desire to hear the rezoning request. The matter is before the Planning Commission for public hearing and will be forwarded to the Council with the Commission's recommendation. The Redevelopment Commission and Alkali PAC are also reviewing the request. Staff will report verbally on their action at the November 29th meeting.

Staff does not support the request for reasons similar to the request for the variance. The main reason is that staff views the two unit addition in the same light as new construction. Staff does not support waiver of parking for new construction nor a new four unit project on a 40' x 80' lot with the same undesirable features as previous projects which cause a major re-evaluation of zoning in the Central City.

RECOMMENDATION: Staff recommends the Commission hear the rezoning request and forward a recommendation to the City Council.

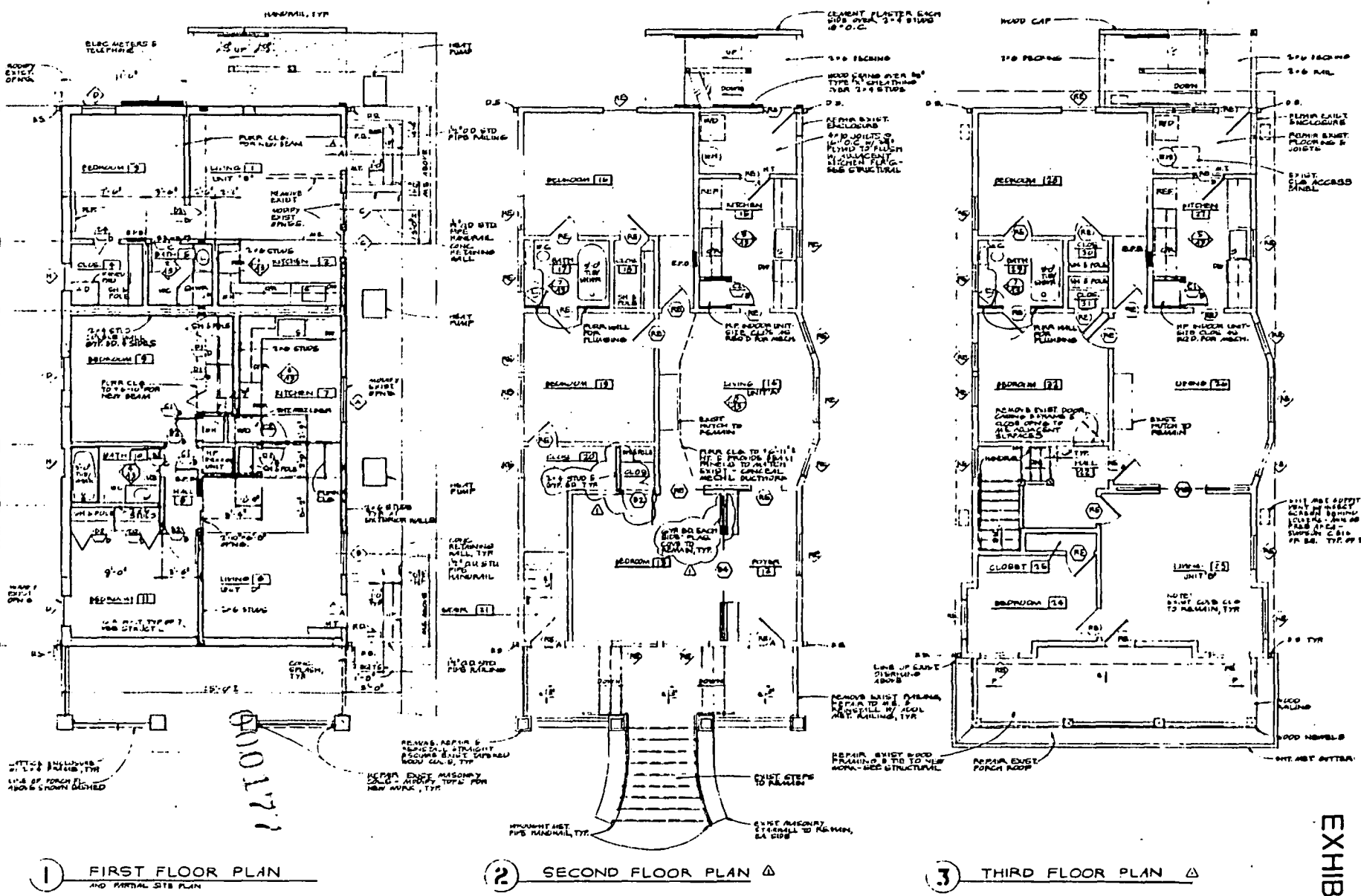
VICINITY - LAND USE - ZONING

2 SECOND FLOOR PLAN

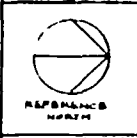
