SUBJECT: UPARR Grant Program: Recreation Services/  
Facilities Master Plan

SUMMARY

It is proposed that the City Council approve submittal of a grant application to the U.S. Department of the Interior for Urban Park and Recreation Recovery Program (UPARR) funding, to finance a comprehensive Recreation Services and Facilities Master Plan.

BACKGROUND INFORMATION

The Urban Park and Recreation Recovery Program provides funds to develop local Recovery Action Programs that identify community needs, objectives, action priorities, and strategies for revitalization of the total public and private recreation system. These Federal grant funds are allocated on a competitive basis. Approximately \$8 million has been allocated to the Federal program in fiscal year 1981-82.

The City's most recent Recreation and Parks Plan was prepared during 1966-68. Given the economic, population, and community development changes which have occurred, a critical need exists to update this plan. It is intended that the Master Plan update will address recreation and parks service deficiencies; a financing plan to include public/private/corporate resources; innovative approaches to programs and facilities; coordination of service agencies; coordination of recreation providers; and a citizen involved planning process. Application for Federal funding under the UPARR Program is appropriate for this project.

FINANCIAL DATA

The estimated total cost of the Master Plan project is \$109,096. The City staff proposes to apply for \$54,096 under the Federal UPARR Grant Program which will be matched by \$55,000 in in-kind contributions.

RECOMMENDATIONS


It is recommended that the City Council approve, by resolution, the submittal of the application for a UPARR Program grant to aid in financing the Recreation Services/Facilities Master Plan.

A RESOLUTION APPROVING APPLICATION FOR URBAN  
PARK AND RECREATION RECOVERY PROGRAM FUNDS FOR  
THE DEVELOPMENT OF A RECREATIONAL SERVICES/  
FACILITIES MASTER PLAN

WHEREAS, the Congress under Title X of Public Law 95-625 has authorized the establishment of a Federal Urban Park and Recreation Recovery Grant-In-Aid Program, providing matching funds to local urban governments for the rehabilitation of deteriorated recreation facilities; and

WHEREAS, the National Park Service is responsible for the administration of the program, setting up necessary rules and procedures governing application by local governments under the program; and

WHEREAS, said procedures adopted by the National Park Service require the applicant to certify by resolution the approval of applications and the availability of local matching funds prior to submission of said applications; and

WHEREAS, Part V of said applications contains assurances that the applicant must comply with; and

WHEREAS, the proposed project for development of a recreational services/facilities master plan is consistent with the California Outdoor Recreation Resources Plan; and

WHEREAS, the project must be compatible with the land use plans of those jurisdictions immediately surrounding the project;

NOW, THEREFORE, BE IT RESOLVED THAT THE City Council hereby:

1. Approves the filing of an application for Urban Park and Recreation Recovery Program fund assistance; and
2. Certifies that said agency understands the assurances in Part V of the application and certifies that it will comply with the regulations, policies, guidelines, and requirements, including A-95, FMC 74-4, and FMC 74-7, as they relate to the application; and
3. Certifies that said agency has matching funds from local funding sources and can finance 100 percent of the project, 50 percent of which will be reimbursed; and

4. Certifies that the project is compatible with the land use plans of those jurisdictions immediately surrounding the project; and
5. Certifies that the project included in this application conforms to the Open Space Element of the City's General Plan; and
6. Appoints the City Manager as agent of the applicant to conduct all negotiations, execute and submit all documents including, but not limited to, applicaiton, agreements, amendments, payment requests, and so on which may be necessary for the completion of the aforementioned project.
