- b. California State laws: Unruh Civil Rights Act, Fair Employment & Housing Act. (FEHA), California Government Code 11135.
- c. Public Agencies "Good Faith Effort".
- d. Buy-in from the Top.

- f. Common Corrective Actions of the ADA.

Mr. Paravagna answered questions from the Commissioners followed by discussion relative to City's responsibilities, Commissioners roles, and the next steps.

Election of Officers

Commissioner Brown explained City Ordinance No. 2001-050, and the process to follow in conducting the election consistent with the City Clerk's office procedure. He then opened the nominations to elect a new Chair and Vice Chair of the Sacramento Disabilities Advisory Commission.

By majority vote Mr. Thom and Mr. Kysor were elected Chair and Vice Chair respectively.

Mr. Brown asked for motion. Commissioner Benson moved to elect Mr. Thom the Chair and Mr. Kysor the Vice Chair. Commissioner Springer seconded. MSP.
