

Resolved, that the public interest and convenience require, and the City Council of the City of Sacramento hereby orders the following street work to be done, to-wit:

THE IMPROVEMENT OF **Alhambra Boulevard**, from the center line of "I" Street to the northerly curb line of "N" Street; Granada Way and "L" Street in "Alhambra Tract," (as the same is shown on the official map thereof filed in the office of the County Recorder of the County of Sacramento, State of California,); "L" Street, from the easterly line of said Alhambra Tract to a point 250 feet easterly therefrom; Seville Way, from the northerly line of Folsom Boulevard to the southerly line of Granada Way; alley first south of "J" Street, from the easterly line of Alhambra Boulevard to a point 308.45 feet easterly therefrom; northerly one-half of Folsom Boulevard, at its intersection with Seville Way; "K" Street, "L" Street and "M" Street, from the easterly line of 30th Street to the westerly line of Alhambra Boulevard; Folsom Boulevard, from the easterly line of Alhambra Boulevard to the westerly line of 34th Street; and Granada Way and "L" Street, from the easterly line of Alhambra Boulevard to the westerly line of Seville Way, all

in the City of Sacramento to the extent, with the materials and in the manner set forth in Resolution of Intention No. **2196**, passed and adopted by said City Council on **July 21**, 192**7**, reference to which Resolution of Intention is hereby made for a description of said work and improvement, **and of the district to be assessed for the costs and expenses of said work.**

The City Clerk is hereby directed to post conspicuously for five (5) days on or near the Council Chamber door of the City Council notice hereof, with specifications, inviting sealed proposals or bids for doing said work; and to publish twice a notice hereof, inviting sealed proposals or bids for doing said work, and referring to the specifications posted and on file, the said publication to be in the **Sacramento Bee**, a daily newspaper published and circulated in said City of Sacramento and hereby designated for that purpose.

All such proposals or bids shall be received by the City Clerk, at his office in the City Hall of said City, on the **25th** day of **August**, 192**7**, between the hours of **4:00** o'clock p. m., and the hour of **5:00** o'clock p. m., and said day is hereby designated as the day on which at the hour of **8:00** o'clock p. m., the said proposals or bids shall be opened, all of which shall be specified in said notice, and said notice shall require with said proposals or bids a check certified by a responsible bank, payable to the City of Sacramento, for an amount not less than ten per cent (10%) of the aggregate of the proposal, or by a bond for the said amount, and so payable, signed by the bidder and two sureties, all as prescribed by law.
