Summary:

The Department of General Services, Fleet Management Division, has a requirement to purchase three replacement automated side loaders and one additional automated side loader for use by the Department of Utilities, Solid Waste Division. These automated side loaders are used for residential refuse collection throughout the City. Staff recommends that the Mayor and City Council accept the results of Bid No. B061181037 and award a contract to Sacramento Truck Center in the total amount of \$783,861.

Committee/Commission Action: None.

Background Information:

Three Department of Utilities automated side loader refuse trucks are due for replacement based on age and condition, and one additional unit was requested due to an increase in routes. The City went out to bid in November 2005, and received one responsive bid from Sacramento

Truck Center. Sacramento Truck Center is located within the City limits. Therefore, staff recommends that in the best interest of the City, the Mayor and City Council adopt the attached resolution awarding a contract to Sacramento Truck Center, 100 Opportunity Street Sacramento, CA in the total amount of \$783,861.

Financial Considerations:

There are sufficient funds in the Fleet Management vehicle replacement fund and the Solid Waste fund for this purchase.

Environmental Considerations:


This recommendation is consistent with the City's Low Emission Vehicle Acquisition Policy and the fuel strategies adopted by City Council. These vehicles are certified low emission units and operate on liquefied natural gas.


Policy Considerations:

PURCHASE OF AUTOMATED SIDE LOADING REFUSE TRUCKS

BACKGROUND

- A. The Department of General Services, Fleet Management Division, has a requirement to replace three automated side loaders and purchase one additional automated side loader for use by the Department of Utilities, Solid Waste Division.
- B. The City went out to bid in November 2005 and received only one responsive bid from Sacramento Truck Center, which is located within the Sacramento City limits.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The specifications of Bid No. B061181037 are hereby adopted.
- Section 2. The City Manager is authorized to award a contract to Sacramento Truck Center, 100 Opportunity Street, Sacramento, CA, in the total amount of \$783,861 for the purchase of four automated side loading refuse trucks.
