Patio cover will maintain existing side yard setback and will be 21' from back property line. <u>No Planning concerns.</u> Square footage and lot coverage info: lot size, per metroscan is 6264. Per Permits Plus, living area is 1888, garage is 410 (counts 100% as is not a recessed garage), and existing back covered patio cover is 181. Proposed patio cover is 232. Total proposed lot coverage is 2714 / 6264 = 43.32% out of possible 45%, and this is not even utilizing the 100 sq. ft. patio cover credit available.
