**SUBJECT: Crocker Art Museum Division - Appropriation Increase
For the Art Ark Mobile Unit Outreach Program Grant**

SUMMARY

This report recommends a \$8,000 increase to the FY 1980-81 budget of the Crocker Art Museum Division to reflect National Endowment for the Arts funds granted to support a museum outreach program and related operating expenses.

BACKGROUND INFORMATION

The National Endowment of the Arts, on January 29, 1981, approved the allocation of funds under its Wider Availability of Museums programs. Funds are distributed in accordance with criteria and a timetable established by the Endowment.

On March 25, 1980, the City Council adopted Resolution No. 80-171 approving the application for the grant.

FINANCIAL DATA

The grant of \$8,000 will be funded by Federal Endowment funds. No City matching funds are necessary.

RECOMMENDATION

It is recommended that the City Council, by resolution, approve an increase in appropriations for \$8,000 to fund an outreach program of the Crocker Art Museum.

RESOLUTION AMENDING THE CITY BUDGET FOR FY 1980-81
FOR THE DEPARTMENT OF COMMUNITY SERVICES
(CROCKER ART MUSEUM - ART ARK OUTREACH PROGRAM GRANT)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The receipt of a grant from the National Endowment of the Arts requires an appropriation increase of \$8,000 for the budget of the Department of Community Services
2. The City budget for FY 1980-81 is hereby amended:

By adding thereto the sum of \$8,000 to budget number 1-01-2270-0000-4399 relating to the expenditure of funds for the grant from the National Endowment for the Arts.
3. The above appropriation increase is supported by additional revenue that is forthcoming from the National Endowment for the Arts.
