SUBJECT: Resolution Approving Negative Declaration for FRONTAGE IMPROVEMENTS AT
FIRE STATION NO. 17, BELL AVENUE AND MARYSVILLE BOULEVARD

SUMMARY:

The Environmental Coordinator has reviewed the subject project and finds that it will not have a significant adverse effect on the physical environment and therefore recommends that the project and a Negative Declaration be approved by the City Council.

BACKGROUND:

In accordance with State E.I.R. Guidelines for Implementation of the California Environmental Quality Act of 1970, dated December 1976, an Initial Study was performed. As a result of this study, it was determined that the subject project would not have a significant adverse effect on the physical environment and a draft Negative Declaration was prepared. On February 18, 1982 the Negative Declaration was filed with the County Clerk. On February 22, 1982 Notice of Opportunity for Public Review of the draft Negative Declaration was published in The Sacramento Union. The appropriate length of time has elapsed for receipt of comments regarding the Negative Declaration, with no comments having been received.

RECOMMENDATION:

The Environmental Coordinator recommends that the attached resolution be passed which will:

1. Determine that the proposed project will not have a significant effect on the environment.
2. Approve the Negative Declaration.
3. Approve the project.

RESOLUTION APPROVING NEGATIVE DECLARATION FOR

FRONTAGE IMPROVEMENTS AT FIRE STATION NO. 17

BELL AVENUE AND MARYSVILLE BOULEVARD

WHEREAS, on February 18, 1982, R. H. Parker, the Environmental Coordinator of the City of Sacramento, filed a Negative Declaration with the County Clerk of Sacramento County for the following proposed City initiated project: FRONTAGE IMPROVEMENTS AT FIRE STATION NO. 17 - BELL AVENUE AND MARYSVILLE BOULEVARD

WHEREAS, the prescribed time for receiving appeals has elapsed and no appeals were received.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

NO PROJECT - IF THE PROJECT WERE NOT CONSTRUCTED, THE FIRE FIGHTING
EQUIPMENT COULD BE DAMAGED IN EXITING FROM THE FIRE STATION BECAUSE
OF THE EXISTING DETERIORATED SHOULDER CONDITIONS, AND THE FIRE
PROTECTION IN THE AREA WOULD BE PLACED IN JEOPARDY.
