**SUBJECT: APPROVAL OF CHANGE ORDER NO. 3 IN THE AMOUNT OF \$25,722.91
FOR THE STOCKTON BOULEVARD/2ND AVENUE REALIGNMENT
PROJECT (PN:TA21)**

LOCATION AND COUNCIL DISTRICT:

Stockton Boulevard/2nd Avenue, Council District 5

RECOMMENDATION:

This report recommends that the City Council:

- Approve Change Order No. 3 in the amount of \$25,722.91 with Biondi Paving, Inc.
- Ratify the City Manager's prior actions executing all previous change orders

SUMMARY:

The construction contract for the Stockton Boulevard/2nd Avenue Realignment Project was awarded to Biondi Paving in the amount of \$915,958. Change Order No. 3 will compensate the contractor for pavement planing and overlay of the intersection, removal of underground buried railroad tracks and minor modifications to existing curb, gutter and sidewalk.

BACKGROUND INFORMATION:

The University of California is funding the major cost of this project. The project includes realignment of 2nd Avenue, a new traffic signal and landscaping.

FINANCIAL CONSIDERATIONS:

As of September 14, 1998, the unobligated balance was \$28,000, which is sufficient to cover the cost of Change Order No 3.

ENVIRONMENTAL CONSIDERATIONS:

The University of California regents ratified a Negative Declaration for this project.

POLICY CONSIDERATIONS:

Approval of this change order, ratification of the City Manager's prior actions, and resetting City Manger authority are consistent with the Sacramento City Code, Title 58.


MBE/WBE:
