
Dear Building Inspector:

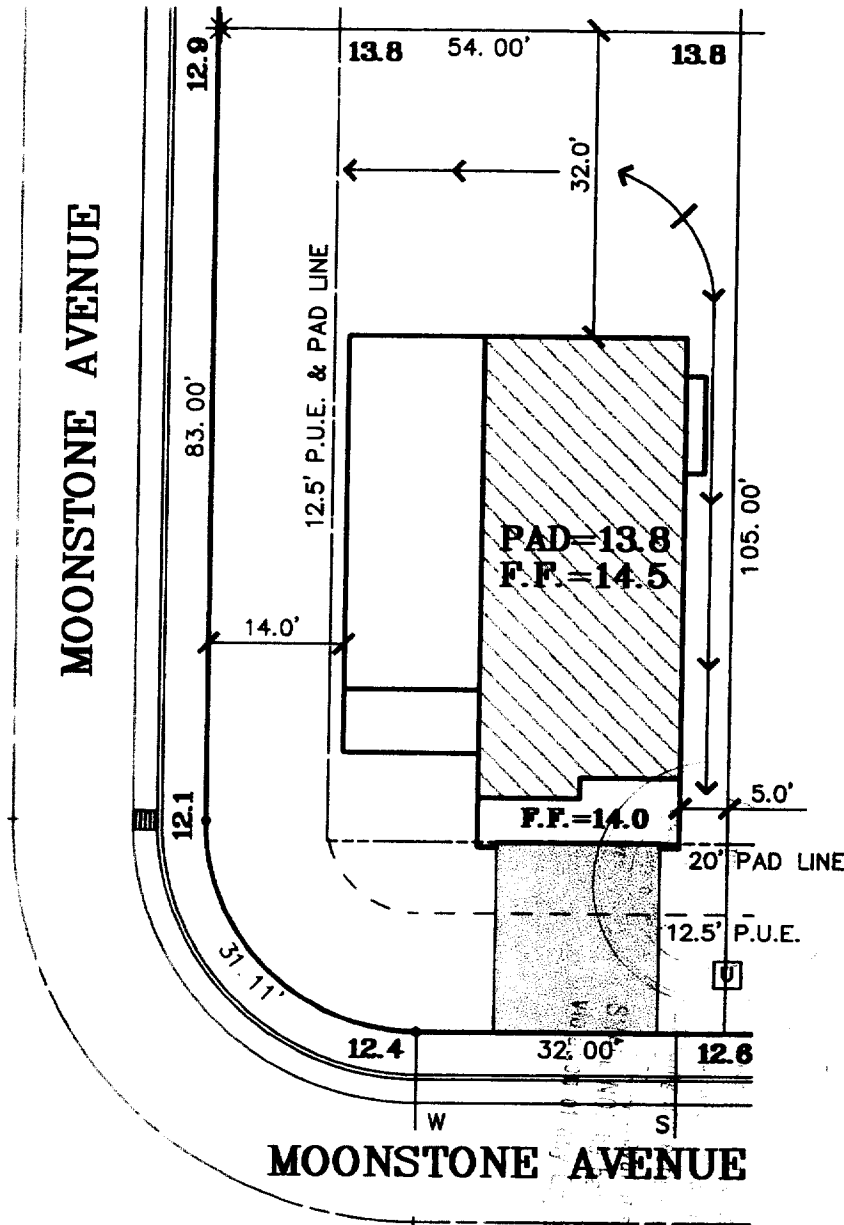
